PRAYER

The next three days became known as the Stonewall Riots. Each June, the GLBT community marks this historic turn of events and the assertion of our humanity and dignity with Pride celebrations. Pride Month is observed worldwide. And in our state from the northern most parts of Humboldt county to San Francisco, Monterey, Fresno, here in Sacramento, Los Angeles, Long Beach, Palm Springs, San Diego. And communities like the Inland Empire, Orange County, Bakersfield, Santa Barbara, Modesto, San Jose, Santa Cruz, Pasadena, Chico, San Luis Obispo, Torrance and Studio City each have Gay Pride celebrations.

So on this rainbow morning we too mark and celebrate the Gay, Lesbian, Bisexual, and Transgender community's Pride Month in our Capitol. We know Holy One of Blessing You shower us with love and understanding. You bring healing into our midst for this community has been reeling from the blows and trauma foisted upon it with the passage and upholding of Proposition 8 and the diminution of our civil rights. Never before in our history has the Constitution been amended to take away a group's civil rights. The GLBT community through its celebration of Pride Month and through the recognition of it here in this great Assembly, we pray will never turn back in its pursuit of full equality and liberty. We pray you will be with us in restoring the full dignity and civil and human rights to the gay and lesbian community that the institution of marriage brings. This Pride Month of celebration across our state provides all of California the opportunity to assert the human worth and dignity of gay and lesbian, bisexual and transgender people. Each one made in God's image, B'tzelem Elohim. Baruch Atah Adonai Eloheinu Melech Haolam Sheasani v' shasnu b'tzelem Elohim. Praised are You Eternal One, Source of the Universe who created me and created all of us in the Divine Image. So may it be God's will, Ken Yehi Ratzon.
