I am signing Assembly Bill 1285, which would allow the State Board of Education to authorize a waiver for the Fresno Unified School District (Fresno USD) to provide extended day mathematics and language arts instruction at the Cooper Middle School.

The intent of the bill is to provide Fresno USD the option of implementing this program. The bill does not create a state mandate, since implementation is subject to local discretion. Therefore, the measure will assist the district in enhancing math and language instruction for students at no added cost to the State.

#### Governor's Message—Assembly Bill No. 1433

Governor's Office, Sacramento June 20, 2002

To the Members of the California Legislature:

I am signing Assembly Bill 1433 which will ensure that California National Guard members and other military reservists who are ordered to military service receive financial protections consistent with the federal *Soldiers and Sailors Civil Relief Act of 1940 (SSCRA)*.

The men and women who serve our state in the National Guard and who are called to active military service must leave their civilian jobs and sometimes experience financial hardships as a result of this service. While existing state and federal law provide some protections to these men and women; there are inconsistencies in these laws. This legislation conforms state law to the SSCRA and will provide similar protections for National Guard members and reservists with respect to, among other things, credit obligations, rental agreements, court proceedings as well as eviction protection for the families of military members.

AB 1433 will ensure that equal protection is provided to all California National Guard members, as well as other reservists, who unselfishly put their civilian lives on hold to serve and protect millions of Californians.
