Dear Mr. Wilson: I am writing this letter for the purpose of establishing legislative intent regarding the provisions of Section 8 of Senate Bill No. 88.

Specifically, Section 8 provides an exemption to existing law concerning the application of the California Environmental Quality Act (CEQA) for a city, county, or city and county when passing ordinances that "prohibit the drilling or new or deeper groundwater wells or to limit or prohibit increased extractions from existing groundwater wells, through stricter conditions on the issuance of well permits or changes in the intensity of land use that would increase the demand on groundwater."

The provisions of Section 8 are not intended to grant authority, expressed or implied, to a city, county, or city and county to determine cropping patterns or crop selection on private property.
