Legislative Intent—Assembly Bill No. 205

Dear Chief Clerk Parker: The purpose of this letter is to express my intent in enacting AB 205, which assists Californians with past-due energy bills, supports and expedites the State's transition to clean energy and helps maintain energy reliability during extreme events.

AB 205 establishes a State-led Strategic Reserve that will be used in extreme events such as heatwaves and only as a last resort. The Strategic Reserve exists on top of and after procurement by load serving entities, including local publicly owned utilities, and does not modify or reduce their obligation to meet existing reliability requirements set in law and regulation. The Strategic Reserve also does not modify the responsibility of California balancing authorities to ensure reliability, consistent with existing law and regulation. Additionally, the bill requires the Department of Water Resources (Department) to prioritize feasible, cost-effective zero-emission resources over fossil fuel resources. However, continued, aggressive progress towards clean energy remains critical to ensure that climate change impacts do not further increase our adaptation challenges.

The Strategic Reserve is not intended to fund facilities that would operate as base load for the energy system, but only as a supply of last resort to maintain energy reliability and affordability during extreme events while the State continues its transition to a clean and equitable energy system. The assets in the Strategic Reserve would be deployed according to a loading order that prioritizes zero-emission resources and relies on fossil-fuel-based resources only when all other cost-effective options have been exhausted.

AB 205 is intended to ensure that the California Energy Commission's (CEC) siting of facilities procured by DWR is done with more public involvement and environmental review than occurs under emergency proclamation, while simultaneously improving electricity reliability during extreme events. It is the intent of the Legislature to create a consolidated and expedited process for permitting of DWR facilities that is similar to the CEC's process for certifying thermal power plants under the Warren Alquist Act (Public Resources Code Section 25500, et seq.), including providing an equal level of environmental and public health protection. AB 205 will limit the potential of environmental and public health impacts by requiring that the siting of DWR owned facilities be at locations that have existing access to necessary infrastructure, and not on undisturbed or important natural resource or cultural resource lands.

The Commission would be required to give notice to property owners within 1,000 feet and relevant local, regional, and state agencies and California Native American tribes. It is the intent of the legislature to ensure the communities surrounding the proposed DWR facility have an opportunity to participate in the siting process and to ensure that the potential impacts are minimized and air quality impacts are fully mitigated. The DWR would have to present its contracts and investment plans to CEC at a regularly noticed meeting.

Additionally, the Commission would be required to consult with the California Coastal Commission, the Bay Conservation and Development Commission, and other state, regional, and local agencies as relevant, to ensure that the Commission rigorously enforces state policies and environmental protections. It is the intent of the Legislature that this consultation be meaningful and collaborative.

Furthermore, this bill does not facilitate any permitting for expiring power plants that the Department would merely be funding. Thus, the owner/operator of an existing power plant planned for retirement would need to follow existing procedures to renew or extend any permits or licenses. AB 205 of itself would not allow for any extension of operations of the Diablo Canyon Power Plant. Additional legislation, as well as federal and state regulatory approvals, would be required for such an extension.

AB 205 establishes programs, in conjunction with funding appropriated by AB 178 and AB 180, that appear sufficient to meet the near-term reliability challenges as forecast by the California Energy Commission and does not authorize siting of resources outside of these emergency conditions.
