**SPECIAL REMARKS**

Speaker pro Tempore Ward introduced Luis Valdez, playwright, director, and activist, whereupon he addressed the assemblage:

It is my distinct honor today to join you all in this ceremony celebrating the ascension of Representative Robert Rivas as the new Speaker of the Assembly for our glorious state of California.

I say this with all the pride engendered by the achievements of one of our own local heroes in San Benito County, as he now speaks not only for the 29th Assembly District encompassing the Salinas and Pajaro Valleys, but also for our entire Golden State from San Diego to the Oregon border.

The impressive evolution of his voice as a humble grassroots leader, as a grandson of an activist farmworker, who attended school in the Mission pueblo of San Juan Bautista and now serves and resides in the City of Hollister with his wife Christen and family, speaks to the essence of our democracy itself.

Almost sixty years ago, in the middle of the Great Delano Grape Strike, I recall hearing César Chávez pointedly talk to his Huelguista troops on the picket lines about the long term effects of organizing farmworkers in California.

It would, he predicted, not only result in the first union contracts for fieldworkers, it would inevitably lead the poorest and most disenfranchised people in the state to take control of their own destinies, by exercising the power of the vote and starting to elect their own reps to school boards, city councils, supervisors, and inevitably the California State Assembly and Senate.

Robert Rivas's trajectory as a conscientious San Benito County supervisor before he ran for the Assembly is such an excellent case in point.

But what matters most is that this young leader, who grew up in farm worker housing, has the integrity and compassion to do something for all the people of the state, but especially the people at the very bottom.

Regrettably, from Sacramento to Washington D.C., these are trying times in our democracy, as the public's faith in its political leaders has been challenged by the blatant lies and corruption in our bicameral legislative bodies and even in the White House.

As the founding artistic director of El Teatro Campesino, and as a Hollywood filmmaker, it has been my mission since 1965 to activate our audiences to take control of their own political destinies by speaking truth to power.

The Mission town of San Juan Bautista was founded when George Washington was still President.

It has been our home for over 52 years, but I cannot think of anything that makes us more proud than to have one of our beloved local homeboys speaking for our Golden State, with one of the most powerful economies in the greatest democracy in the world.

Millenia ago, our ancient Nahuatl-speaking indigenous ancestors in America practiced a kind of democratic consensus by describing their leaders not as god-given kings but rather as "ui tlatoani" or "chief speakers" of the people.

It is with this humbling thought in mind that I extend my fondest abrazo with pride to the new Chief Speaker of the State of California, nuestro hermano, Robert Rivas.

We're going to be there right alongside our new Speaker, pushing the powerful and fighting for those families who are still hardworking but, yet, still poor. And from time to time, Roberto, we will push you because we support you. And we love the spirit that propelled you to feed off your experience, so you can make a difference in the lives of families like ours. The generations that came before us are proud of us, and I know you as our Speaker feel the weight of that.

So I want to congratulate you and your family and thank you for keeping us inspired to fight for the California Dream that only would have you as our Speaker and a kid like me who came here as an illegal immigrant with my parents, crossing the border on a dangerous trek to achieve that dream. I am ready to get to work and I know you are too. No solamente "Sí se puede," pero "Sí se pudo."

**Assembly Member Zbur Addressed the Body**

We are living in truly momentous times. The issues we face are immense. A radical Supreme Court ripping away abortion rights, ending affirmative action, and—just this morning—allowing businesses to discriminate against same-sex couples. Climate change threatening our planet and way of life. LGBTQ+ kids and families under attack and McCarthy-era forced outing policies threatening the safety of students and teachers. Robert has fought throughout his public life for things that weren't at all easy—like protecting his rural community's groundwater from the damaging impacts of fracking. With my own eyes, I saw him stand up for LGBTQ+ kids while he was a school administrator in Hollister. He was one of the LGBTQ+ community's earliest champions in rural California, not because that was the popular thing to do at the time, but because it was right and just.

He understands the need to address climate change with urgency. He will be a rock solid champion protecting abortion rights and reproductive freedom. And he will stand strong to protect LGBTQ+ people, our Jewish communities, and communities of color throughout the state. He will also fight for our schools, small businesses, and our economic growth.

First Lady Rosalynn Carter once said, "A leader takes people where they want to go. A great leader takes people where they don't necessarily want to go, but ought to be." That's why I'm so proud to support him today as he leads us not just where it is easy to go, but where we need to go.

Rob, I can't wait to call you Mr. Speaker. I congratulate you on today's achievement and look forward to being by your side as you lift up the people of this state to achieve our greatest potential.

#### **SPECIAL BIBLE ON LOAN FROM CALIFORNIA STATE LIBRARY**

A 522-year-old Parisienne Bible, on loan from the California State Library, was presented and held by Christen and Melina Rivas. The Parisienne Bible was printed in Paris, France, by Jean Petit, who finished printing the text on July 28, 1501. This Bible has been used to swear in several former California Governors and legislative leaders since 1870.

#### **OATH OF OFFICE ADMINISTERED**

At 10:35 a.m., Speaker-designate Robert Rivas appeared at the bar of the Assembly and took and subscribed to the following oath of office administered by the Honorable Patricia Guerrero, Chief Justice of California. **PRESENTATION OF SPEAKER OF THE CALIFORNIA STATE ASSEMBLY  
THE HONORABLE ROBERT RIVAS**

Speaker pro Tempore Ward then presented the 71st Speaker of the California State Assembly, the Honorable Robert Rivas, whereupon he addressed the assemblage.

**Address by the Honorable Robert Rivas  
71st Speaker of the Assembly**

It is my great honor to undertake the responsibilities of the Speaker of the California State Assembly. I am humbled, humbled by the trust you have placed in me, on behalf of the people of California, to lead this body and to support the enactment of just laws.

I am proud to lead an Assembly that is the most diverse in California's history, and is among the most diverse legislative bodies in the world. Our diversity is our collective heritage as Californians. Our diversity is what built this state. It is our greatest strength today and it is the foundation of our future.

I can tell you that no one gets to this dais without a great deal of help. And I want to begin by expressing gratitude to you, my colleagues. Since I arrived here in the Assembly, so many of you, on both sides of the aisle, have lent me your advice and encouragement. And I stand here with the greatest respect for the work each of you do every day.

And at this moment of change, I want to acknowledge outgoing Speaker Anthony Rendon. During his tenure, this Assembly has made significant progress for the people of California. We thank you, Mr. Speaker. We thank you for your leadership, for your service, and for your deep commitment to our state.

The Governor is with us today. Governor Newsom, with moral clarity and a concern for our most vulnerable has been a relentless advocate for Californians and a relentless advocate during one of the most difficult periods in American history. Mr. Governor, I am grateful, we are grateful, for your leadership and look forward to what we will accomplish together.

It is my great honor to recognize one of the greatest Speakers our country has ever had, our formidable Speaker Emerita, Nancy Pelosi. Madam Speaker Emerita, your relentless fight for our democracy's heart and soul inspires me and inspires every member of our caucus. Thank you for all you do.

And I am so proud that my very own representative in Washington D.C., the great Zoe Lofgren, is in the house. I also want to recognize our fearless Senate Pro Temp, and former Assembly Speaker, Toni G. Atkins. I look forward to working with you, Madam Pro Temp.

Also, I'm so appreciative of every dignitary and Constitutional Officer here with us today; California is blessed, blessed to have these trailblazing leaders guiding us. Thank you for your service and thank you for being here. I also want to acknowledge a very special person; Dolores Huerta is here. Dolores is a legend, whose work has lifted up millions across the world. She's one of the most consequential leaders of our time. Dolores, you have been a friend to my family for so long, a personal mentor to me. Your commitment to justice is an inspiration to us all. Thank you for everything, and thank you for always being there for me.

We are also joined this morning, here on our Assembly Floor, by many farmworkers—women and men, whose daily labor, whose

sacrifices are and have always been the backbone of California's fifty-billion-dollar agricultural economy. Please help me honor and welcome them to our state capitol. And, it is with a full and grateful heart that I acknowledge two incredible women, my wonderful mom, Mayra Flores, and my incredible ninety-year-old grandmother, who helped raise me and my brother, Rosaenna Flores. In addition to my mom and grandmother, my entire family is here today.

The strength and determination of my mom and grandmother, the strength and determination of my family, have shaped every part of my life. Words can never express my gratitude to them and what it means to have them here with me. It's tough to find the words because the odds were stacked against our family when we immigrated to California in the 1960s, traveling some 1800 miles from Mexico. The tough odds that we faced bind us to others who've settled here: Chinese laborers, who built the railroads. Fortune-seeking 49ers. Black Americans leaving the postbellum south. Oakies, fleeing the Dust Bowl. Mexican and Latin Americans, migrating to work the fields. LGBTQ Americans, looking for a place where their rights would be respected. And there are so many other examples.

My grandfather, Servando Flores. His first job was picking and packing grapes at Almaden Vineyards. My mom was just eight years old then. Our family, they lived in a two-room farmworker unit, a unit that often glistened with spray from the pesticides used on the fields.

In the early 1980s, my brother and I, we were raised in that same humble home. By then, more family members lived with us. Eight people, three beds, and a single bathroom. We were poor. Our home was crowded. But my family was always focused on building a better life for ourselves and for others. Despite great personal risk, my grandfather, he organized with the UFW and Dolores Huerta, and won a first-ever labor contract for him and his fellow workers. My grandmother and great grandmother, they worked the night shift at a tomato cannery to keep food on our table.

My mom, she worked as a secretary before becoming a kindergarten teacher. She sold Mary Kay and Rainbow vacuum cleaners to make sure my brother and I had a chance at a better life. In some ways our lives were difficult. But I was raised in the spirit of service, elevated by a strong community. A community where people took care of each other and I was surrounded by so much love.

Love, community, and service—those are the three forces that got me to the California State Legislature. Love, community, and service, those are the three forces that have helped me understand that our lives are only worthwhile when we bring others up as we rise.

In these kinds of speeches, you hear a lot, a lot, about the California Dream. The phrase is used so much that it can lose its meaning or become a cliché. But for our family, the Dream, the California Dream, is the foundation and fabric of our lives. As I mentioned, my grandfather, he was a farmworker his entire life and I grew up in farmworker housing. And today, I stand before you as Speaker of the California State Assembly. That, that is the California Dream.

But this trajectory, this trajectory was only possible for us because the California my grandparents immigrated to make it possible. The opportunities here at that time, they were greater than anywhere else. But to be candid, I often wonder, as many do, I wonder if our story would still be possible today.



You see, in 1988, my grandparents, aunts, uncles, and cousins pooled together their savings to buy a small house for \$140,000. It was a massive, massive investment, but it was doable. The house was ours. It gave us a sense that, that our future was not so precarious, that there was a place for us in California.

But today, homeownership for anyone except the most affluent Californians is simply out of reach. Our state's average home price today, which recently dropped, dropped to just under \$775,000. An entire generation of Californians will be locked out of homeownership if we do not do more.

Education is another example. I started my life in very humble surroundings, but went each day to public schools, schools that gave me a great education. After high school, I went to two of California's public universities in the CSU system. But today, many young Californians are asking if college is actually worth it, and it's no surprise, given the massive costs of attending college. At every stage of life in California, from early schooling to getting a higher degree to that crucial step of buying a first home, success, success feels increasingly out of reach. And it's not just those with the lowest incomes who are struggling.

For three years in a row and for the first time in our state's history, the population of our state has declined and declined at every income level. The most visible sign of our times, the encampments under our highways and on downtown streets. But working- and middle-class families, they're facing the same pressures and asking the same question: Is there still a place for me in California?

Make no mistake, California is still the greatest state in the union. Incredible natural resources. Creativity and innovation. Diversity. Energy. And a history of welcoming everyone who chooses to come here and work hard. Yes, California is the most populous state in the country. Yes, California is the 4th largest economy in the world. But if we, in this room, do not act, and act with greater urgency, it will get more and more difficult to build a good life here.

I feel, and I know you all do too, a great sense of responsibility, responsibility because we are the ones who can keep the door open for the next generation. We are responsible for protecting the building blocks of Californians' everyday lives—from the water we drink to the air we breathe, from children's schools to our public hospitals. It is on us. And to face these challenges, we must return our attention to the basics. We must elevate California's working- and middle-classes by enacting practical measures. Measures to lift the economic burden they face. We must make our public services the best in America. We should have the best schools, roads, hospitals. And we don't.

It's time to ask ourselves why that is, and take real action, even when it's tough or unpopular, to fix it. We must use every tool at our disposal to end homelessness, because the inhumane conditions on our streets are completely unacceptable. And we must achieve all this, all this, while continuing to do what California does best: Protecting our incredible environment and protecting the right of every Californian to live, to love, to choose, and to thrive.

This will mean focusing less on how many bills we can pass and more on the impact we are having. Sometimes this will mean going back and fixing something, rather than passing a new law. It may mean saying "no" to an interest group that has had our back in the past. It may mean reaching out to a colleague whose beliefs are different from our own.



What's clear, we must work with urgency and unity. Unity that is backed by mutual trust and respect. And today, I pledge to you to do whatever I can to reinforce these values. This approach will allow us to make measurable progress on the most critical issues facing Californians, and it will show the rest of the country that progressive government works.

I want to close by thanking the two most important people in my life, my wife, Christen, without whose love and support I would not be here, and our precious daughter, Melina. Raising Melina is the most rewarding thing I have ever done. Being a father has given me a lot of perspective, and I know, that every parent in this room knows what I'm talking about. I think often about Melina's life. Her life in thirty years, when she has a family of her own. Her life in fifty years, when her children have gone to college. And in seventy years, when she is looking back on a long and happy life. I want her to make that life, here, in California.

That means ensuring as your Speaker, that the California dream that elevated me, that has elevated so many of us, can elevate her, and every member of her generation. That is our responsibility. That is our mission. We will get it done, and we will get it done together. Thank you very, very much.
