Last year I vetoed a similar measure, AB 781. In that veto message I stated that "the appointments to this council should be reserved exclusively for the Executive Branch. Implementation of the Education Technology Act is an executive function, not legislative."

Since this concern is not addressed, I have no choice but to veto this bill.
