At 11:48 a.m., a special ceremony was convened to honor Members retiring from the California State Assembly.

WHEREAS, The tenure of the Honorable Fred Keeley with the California State Assembly is drawing to a close following six years of exemplary service, and it is appropriate at this time to highlight some of the many achievements of his illustrious tenure and to extend to him the highest commendations of the people of the state; and

WHEREAS, Most noted for his commitment to protecting the environment, raising standards for higher education, and working to promote social justice, Fred Keeley was first elected to the California

State Assembly in November 1996, to represent the 27th District, the Monterey Bay area, and was reelected in 1998 and 2000; and

WHEREAS, Upon the convening of the 1999–2000 session of the Legislature, Mr. Keeley was appointed Speaker pro Tempore of the Assembly, and was reappointed to this leadership position for the 2001–02 session, and as Speaker pro Tempore, Mr. Keeley serves as presiding officer of the 80-member Assembly, leading the body through the daily agenda of business on the Assembly floor, which includes debate and votes on legislation; and

WHEREAS, Speaker pro Tempore Keeley is the highest-ranking member of the Speaker's leadership team, which is responsible for the development of major policy and strategic initiatives for the Assembly's Democratic majority; Mr. Keeley previously served on the Speaker's leadership team as the Democratic Caucus Chair, a position he held from March 1998 until he was designated Speaker pro Tempore; and

WHEREAS, In addition to his role in Leadership, Mr. Keeley has served on various committees, including Budget, Budget Subcommittee on Resources, Natural Resources, Insurance, Public Safety, Public Employees, Retirement, and Social Security, and Elections, Reapportionment, and Constitutional Amendments; and

WHEREAS, Mr. Keeley's legislation and local accomplishments consistently reflect his commitment to energy conservation, the environment, education, and economic and social justice issues, and some notable accomplishments include taking the lead in the Assembly's response to California's energy crisis; and

WHEREAS, Mr. Keeley is recognized for his authorship of the two largest park and environmental bonds in the nation's history, and for his authorship of the landmark Marine Life Management Act; and

WHEREAS, Mr. Keeley was widely commended for his leadership in managing the oversight hearings that led to the resignation of Insurance Commissioner Chuck Quackenbush; and

WHEREAS, Mr. Keeley is a 1974 honors graduate of San Jose State University and he is married to Maria Rodriguez-Keeley, who is a human resources manager in the high technology industry in Silicon Valley; and

WHEREAS, Through his public service activities he had made a significant impact on the people of the 27th Assembly District and throughout the state, and he will be greatly missed by those individuals with whom he has been associated; now, therefore, be it

Resolved by the Assembly the State of California, That the Members express their commendations and appreciation to their colleague, the Honorable Fred Keeley, for his outstanding record of dedicated service to his constituents and to all of the people of California, and convey to him best wishes for every success in his future endeavors.

WHEREAS, Sam Aanestad is an oral and maxillofacial surgeon who was elected to the California State Assembly in 1998 to represent the 3rd Assembly District, and Dr. Aanestad and his wife, Susan, have lived in the 3rd Assembly District since 1980 and have three grown children, Kaesa, Erik, and Kirstin, and Kaesa and her husband, Darren Moore, are the proud parents of Rhiannan, the Aanestads' first grandchild; and

WHEREAS, Dr. Aanestad has practiced oral and maxillofacial surgery full-time in Grass Valley and has served as the Vice-Chief of Surgery at Sierra Nevada Memorial Hospital; and

WHEREAS, In the California State Assembly, Dr. Aanestad served as the Vice-Chairman of the Committee on Health, and served on the following committees: Agriculture; Budget; Elections, Reapportionment and Constitutional Amendments; Natural Resources; Rules; and Water, Parks and Wildlife, and his top priority is to serve the needs of the 3rd Assembly District, which includes Lassen, Modoc, Nevada, Plumas, Sierra, Yuba, and most of Butte counties; and
