RE: Tentative Agreement/Memorandum of Understanding (MOU) for Bargaining Units 1, 3, 4, 11, 14, 15, 17, 20, and 21 (SEIU Local 1000), 7 (CSLEA), 8 (CAL FIRE Local 2881), and 19 (AFSCME).

The California Department of Human Resources (CalHR) has reached a new Tentative Agreement/MOU with the union representing Bargaining Unit (BU) 19 (American Federation of State, County, and Municipal Employees). Upon approval by the Legislature and the Governor, and ratification by employee membership, the BU 19 agreement will be effective July 1, 2025, through June 30, 2028. In accordance with Government Code Sections 3517.5, 19829.5, and Senate Rule 29.4, please accept the attached Tentative Agreement/MOU legislative and fiscal summaries.

CalHR has also reached MOU Addenda (Side Letter) agreements with BUs 1, 3, 4, 11, 14, 15, 17, 20, and 21 (SEIU Local 1000), BU 7 (California Statewide Law Enforcement Association), and BU 8 (CAL FIRE Local 2881). These Tentative Agreements/MOUs and Side Letters, among other things, address the budget shortfall by implementing the Personal Leave Program (PLP 2025), effective July 1, 2025, through July 1, 2027, and/or reflect Other Post Employment Benefit Prefunding changes through June 30, 2027.

The Tentative Agreements/MOUs and Side Letters include savings measures that contribute to meeting the budgeted reductions in Section 3.90 of the 2025 Budget Act as amended by Assembly Bill 102 (Gabriel, Chapter 5, Statutes of 2025). These successor MOUs and Side Letters are deemed ratified by the State effective July 1, 2025, and represent employee compensation savings of \$352.3 million (\$152.4 million General Fund) in fiscal year 2025–26 and \$379.9 million (\$163.4 million General Fund) in fiscal year 2026–27.

The Tentative Agreement/MOU provisions also carry forward language from previous agreements and make various other recruitment, retention, and labor changes. Additional details for each agreement can be found in the attached legislative and fiscal summaries.
