**Veto Message—Assembly Bill No. 2776**

Governor's Office, Sacramento

July 3, 1998

*To the Members of the California Assembly:*

I am signing Assembly Bill No. 2776 with a reduction.

This bill would appropriate monies from the General Fund to the State Board of Control for payment of a claim submitted by the Public Employees' Retirement System for back interest earnings on deferred employer retirement contributions claimed in the case *Board of Administration et al. v. Wilson, etc.*

However, this bill includes an appropriation in excess of what is needed to pay this claim. Therefore, I am reducing the appropriation contained in this bill by \$5,493,805 to reflect the actual amount owed for this claim as of July 7, 1998. The revised appropriation shall be \$333,040,706.

**Veto Message—Assembly Bill No. 1751**

Governor's Office, Sacramento

July 3, 1998

*To the Members of the California Assembly:*

I am returning Assembly Bill No. 1751 without my signature.

This bill would change the statutory designation of workers' compensation referee to "workers' compensation judge."

I vetoed a similar measure in 1994 (Senate Bill No. 1945), because it would have reversed an important aspect of the 1993 workers' compensation reform. The term "judge" should be reserved for individuals who are accountable to the electorate. Workers' compensation referees are not. They are not subject to any election process by the people or their elected representatives. Nevertheless, there is an existing civil service designation of "administrative law judge" whose duties closely approximate those of workers' compensation referees. I would therefore, be supportive of legislation that designates these employees as administrative law judges.

**Veto Message—Assembly Bill No. 2409**

Governor's Office, Sacramento

July 3, 1998

*To the Members of the California Assembly:*

I am returning Assembly Bill No. 2409 without my signature.

This bill would require that part-time playground positions be part of the classified service if the employee holding such a position also is employed in another, classified position in the school district. In addition, the bill protects any employee who is dual employed as of June 30, 1998 from any loss of hours as a result of this act.

This bill is similar to one I vetoed in 1994, except this time the bill would apply to playground employees who are also employed, presumably less than full-time, in a classified position. The veto message for that bill still applies today: This bill would undermine the flexibility of local school districts to manage personnel and would substantially increase their costs, including the expenses connected with position examinations, hiring procedures, and, in some cases, benefits. School districts need to retain as much flexibility as possible in resource allocation and should not be burdened with unnecessary and restrictive mandates that add cost without benefit.

Dear Speaker Villaraigosa: Please join with me in mourning the loss of a constituent of my district and an icon of all that is noble and good in America, the “King of the Cowboys,” Mr. Roy Rogers. In his passing, we bid farewell not only to an entertainer, but to a great humanitarian, a friend, and a family man, as well.

Roy Rogers died at his Apple Valley home in the early morning of July 6, 1998. He took with him only two very basic things—a feeble body, worn and tired from countless years of commissioned service by his Maker to his fellow man, and a soul, ever blazing and vibrant as the day it was breathed into his being by the God that he cherished. But what Roy Rogers left is much more than we can ever inventory. He left for us a brilliant paradigm of patriotism and a deep and abiding love for his country. Most importantly, however, he left for us a blueprint—a model of the importance in our society of practicing Christian principles and stalwart family values.

He never was an “unreachable star” to the abused and abandoned children to whom he dedicated much time and effort through his charitable organization, the Happy Trails Foundation. He was real and sincere—a worthy hero to legions of fans spanning many generations and continents. He is the timeless epitome of what has always been held up as innocent, wholesome and good in life.

I ask you now the join with me, our colleagues in the California State Legislature, and our constituents in honoring and remembering Mr. Roy Rogers.
