*To the Members of the Assembly:*

I am signing AB 2864, which establishes the Inter-Regional Partnership State Pilot Project to Improve the Balance of Jobs and Housing and the Jobs-Housing Balance Improvement Program.

However, I am signing this bill notwithstanding a drafting error that will make it impossible to spend the funds appropriated in the Budget Act for the Jobs-Housing Balance Improvement Program authorized in the bill.

Therefore, I request that the Legislature pass corrective legislation to establish the special fund to which the budget transferred funds for the program, and provide expenditure authority by making this fund continuously appropriated, both of which were inadvertently omitted from the final version of this bill.

Dear Dotson: The purpose of this letter is to clarify the intent of AB 2051 when it is heard for concurrence on the Assembly Floor. For that reason, I request that the comments below be placed in the Daily Journal the day the measure is heard on the Assembly Floor.

“Comment to subdivision (7) (A): The purpose of the requirement that the vehicle be sold or disposed of “in the same manner as goods that the seller disposes of on its own behalf” is to ensure that the seller has an interest in maximizing the proceeds of the sale or disposition. A seller who sells on consignment motor vehicles owned by members of the general public and has an interest in maximizing the price due to a percentage commission or similar arrangement qualifies as a seller who disposes of similar goods on its own behalf.”

“Comment to subdivision (7) (B): The advertising requirements are designed to and should be applied to create a pool of interested retail buyers or leasees from members of the public. As with any disposition involving the seller under paragraph (A), the seller and the secured party must have an interest in maximizing the proceeds of the sale. The secured party normally should not purchase the motor vehicle under these types of sales.”
