Dear Mr. Speaker: As the author of AB 974, it has come to my attention that some health care service plans provide prescription drugs to enrollees through a mail order program. It is recognized that plans may decide, based on bona fide business reasons, to discontinue drugs provided through a mail order program or to discontinue the mail order program altogether, so long as these plans continue to comply with the provisions of the Knox-Keene Health Care Service Plan Act of 1975. However, nothing in AB 974 should be interpreted, nor is it my intent, to allow plans to discontinue a mail order drug or mail order program for the purpose of circumventing the Knox-Keene Act.
