RE: Tentative Agreement/Memorandum of Understanding
Addenda (Side Letter) for Bargaining Unit 5 (California
Association of Highway Patrolmen)

The California Department of Human Resources (CalHR) has reached a new Tentative Agreement/Side Letter with the union representing Bargaining Unit (BU) 5, represented by the California Association of Highway Patrolmen. Upon approval by the Legislature and the Governor, and ratification by employee membership, the BU 5 agreement will be effective July 1, 2025, through June 30, 2027. In accordance with Government Code Sections 3517.5, 19829.5, and Senate Rule 29.4, please accept the attached Tentative Agreement/Side Letter legislative and fiscal summaries.

The Side Letter addresses the budget shortfall by implementing the Personal Leave Program (PLP 2025), effective July 1, 2025, through June 1, 2027, and reflects Other Post Employment Benefit Prefunding changes through June 30, 2027.

The Side Letter includes savings measures that contribute to meeting the budgeted reductions in Section 3.90 of the 2025 Budget Act as amended by Assembly Bill 102 (Gabriel, Chapter 5, Statutes of 2025). Pursuant to Section 3.90, this Side Letter is deemed ratified by the State effective July 1, 2025, and represents employee compensation savings of \$35.6 million (\$0 million General Fund) in fiscal year 2025–26 and \$51.0 million (\$0 million General Fund) in fiscal year 2026–27.

The Side Letter provisions also carry forward language from the current Memorandum of Understanding and make various other recruitment, retention, and labor changes. Additional details for the agreement can be found in the attached legislative and fiscal summaries.
