*Relative to commending the Honorable Dion Louise Aroner.*

WHEREAS, The tenure of the Honorable Dion Louise Aroner with the California State Assembly is drawing to a close following six years of exemplary service, and it is appropriate at this time to highlight the many achievements of her illustrious tenure and to extend to her the highest commendations of the people of the state; and

WHEREAS, Dion Louise Aroner was elected to the California State Assembly in 1996 to represent District 14, bringing with her more than 20 years of hands-on legislative experience; and

WHEREAS, In September 2000, in recognition of her exceptional leadership in the Assembly, Speaker Robert M. Hertzberg selected Assembly Member Aroner as Democratic Caucus Chair; and

WHEREAS, Most recently, she brought distinction to herself as Chair of the Assembly Human Services Committee, in which capacity she oversaw state programs targeted to the most vulnerable populations, including foster care, CalWORKs, services for disabled Californians, and child care, and she also served on the Appropriations, Aging and Long-Term Care, Budget, Judiciary, Revenue and Taxation, and Water, Parks and Wildlife committees; and

WHEREAS, During her first four years in office, her accomplishments included requiring the sale of trigger locks with every gun sold in California and prohibiting the sale of handgun ammunition to buyers under 21; holding the first-ever hearing on the effects of dioxin pollution on poor and low-income families who are consumers of fish from the bay; obtaining an on-going annual appropriation to increase the wages for child care workers; co-chairing the joint committee on welfare reform where she secured a "safety net" for children, obtained new funds for child care, mental health, and substance abuse treatment, and restored food stamp benefits to immigrants, seniors, and children; and obtaining millions in state funding to rebuild and retrofit aging East Bay school facilities; and

WHEREAS, She authored bills concerning community health care planning and emergency room closures, juvenile justice reform, local government financing, foster care, and CalWORKs, and in the 2001–02 session, she introduced legislation addressing hospital seismic

safety, energy conservation, services for the developmentally disabled, housing, foster family recruitment, access to work for disabled Californians, and legislation prohibiting the execution of the mentally retarded defendants; and

WHEREAS, A 1966 graduate of the University of California, Berkeley, with a Bachelor of Science degree, Dion Louise Aroner began her career as a social worker with the Alameda County Department of Social Services, assisting needy families and the elderly, and in 1971 she served as the President of Service Employees International Union, Local 535, distinguishing herself as the youngest person to serve as the union's president and the first woman elected to that post; and

WHEREAS, In 1976 she became Chief of Staff to Assembly Member Tom Bates, a position she held for 20 years, and in this role she prepared legislation in the areas of child care, disability rights, educational finance, long-term care, children's mental health, GAIN (welfare to work training), adoptions, and foster care, and beginning in 1983 she also served as Staff Consultant to the Assembly Human Services Committee; and

WHEREAS, She served the communities in the 14th District as a board member of the Jewish Community Relations Council for the East Bay, Alzheimer's Services of the East Bay, Crisis Support Services of Alameda County, Highland Hospital Advisory Board, and Vocare House, a halfway house for women, and she has provided leadership on the board of Freight and Salvage, a nonprofit that promotes acoustical music, and is active in the National Women's Political Caucus; and

WHEREAS, Dion Aroner and her husband, David, make their home in Berkeley, and their family includes two children, Josh and Danielle, who are graduates of Berkeley public schools and the University of California, Davis; and

WHEREAS, Through her public service activities she has made a significant impact on the people of the 14th Assembly District and throughout the state, and she will be greatly missed by those individuals with whom she has been associated; now, therefore, be it
