Dear Members of the Assembly: As required by the California Government Code, Section 8542, et. seq., the Bureau of State Audits presents its audit report concerning our review of the State of California's internal controls and compliance with state and federal laws and regulations for the year ended June 30, 1998.

This report concludes that the State continues to experience certain problems in accounting and administrative practices that affect its internal control system over financial reporting and over compliance with federal requirements. Furthermore, these problems result in noncompliance with some state and federal regulations. Although these weaknesses are not individually significant, they have a cumulative effect on the accuracy of reported financial information and on the efficiency, effectiveness, and propriety of the State's operations.

WHEREAS, Willie Brown, a native of East Texas, graduate of Mineola Colored High School, alumnus of San Francisco State College

and Hastings College of the Law, was first elected to the California State Assembly from San Francisco's 18th District on November 3, 1964, a position to which he was reelected to 15 consecutive terms; and

WHEREAS, He ably served the Assembly and the people of San Francisco as Chairman of the Ways and Means Committee, Chairman of the Revenue and Taxation Committee, and Majority Floor Leader, using his agile mind and exceptional skills to master the intricacies of appropriations, taxation, budgets, and political strategy; and

WHEREAS, On December 1, 1980, he became the first African American ever elected as Speaker of the Assembly, a position he held continuously until June 5, 1995, the longest such tenure in the history of California; and

WHEREAS, During the course of his distinguished career in public service, he authored landmark statutes that became models for federal programs and for legislation in other states, including: the Child Health and Disability Prevention Act, which established mandatory health screening for school children; the Economic Impact Aid Program, which earmarked special funds for poor, inner-city, and rural schools; the Consenting Adults Act, a civil rights measure which ended criminal penalties for private sexual behavior; the Urban Parks Program; the nation's first state budget allocations for AIDS research; and the Bank Float Act, which gave California consumers quicker access to funds deposited in financial institutions; and

WHEREAS, As Speaker of the Assembly, he shaped, influenced, and dominated public policy and politics in California to a greater extent than any other single public official during the last one-third of the twentieth century, serving as a powerful, persuasive, and effective advocate and protector of policies and programs to aid the poor, the young, the elderly, the disabled, and the disenfranchised; now, therefore, be it

Dear Dotson: This is to clarify my intent with respect to two issues raised by Section 513 of AB 60.

In Section 513, an employer is prohibited from encouraging or soliciting an employee to request personal time off and to make up that time within the same workweek and without overtime compensation. I want to make clear that my intent is not to prohibit an employer from informing employees of their right to make a request pursuant to this Section. I expect that the Industrial Welfare Commission (IWC) will

issue a notice that employers will be able to use to inform their employees of the personal time off option.

Second, Section 513 requires that for each occasion that an employee requests personal time off that would be made up within the same workweek without overtime compensation, the employee must provide a signed written request. As with other issues raised by this bill, it is my intent that the IWC would prescribe the type of circumstance, if any, in which the request made pursuant to this Section could govern personal time off beyond any particular workweek. My intent is that personal time off will be used to supplement the regular work schedule or alternative workweek schedule. Accordingly, regulations by the IWC should restrict the length of time authorized by any particular written request to a relatively brief period beyond one week.
