REQUEST FOR UNANIMOUS CONSENT TO PRINT IN JOURNAL

Assembly Member Shelley was granted unanimous consent that the following communication from the Chief Clerk, and Opinion of Legislative Counsel be printed in the Journal:

July 15, 1998

Dear Mr. Speaker: Please find attached a Legislative Counsel opinion that should clarify the "in print" and public notice requirements for conference reports that are submitted to the Assembly Desk in accordance with Joint Rule 30 and Assembly Rule 68.8. I respectfully request that this enclosed letter and the Legislative Counsel opinion be entered in the Daily Journal to assist the public and membership in applying the aforementioned rules relative to conference committees.

Joint Rule 30 requires the following:

"The consideration of a committee on conference shall not be in order until the bill in the form recommended by the report of the committee on conference has both been in print and been noticed in the Daily File for not less than *one* legislative day."

In addition, Assembly Rule 68.8 specifies the following:

"No conference report may be heard by the Assembly until it has been in print for **two days** (i.e., calendar) prior to being taken up by the House." (Senate Rule 29.9 requires a similar two-calendar day waiting period.)

Over the past twelve years the Senate and Assembly have interpreted these rules in a differing fashion. This has resulted in unnecessary confusion and conflicting advice on procedural questions involving joint actions by both Houses. In some instances, a conference report submitted on a Thursday was eligible in the Senate on the following Tuesday, but not eligible in the Assembly until that Wednesday, almost a week after the report was submitted. This is because the Assembly

interpreted Joint Rule 30 to require that the conference report be in print for what in effect is two (rather than one) legislative days in addition to two calendars days.

The Legislative Counsel opinion offers a pragmatic application of the conference committee procedures. Based on this opinion, the two-Houses could adhere to a uniform interpretation of the rules. Under any scenario, a conference report would not be eligible to be taken up until the third day after it is submitted to the Assembly or Senate Desk, at the earliest. For example, a conference report submitted on a Thursday (assume no Friday–Sunday Session) would be eligible on the following Tuesday, one legislative day after Monday's session.

Legislative Procedure: Conference Committee Reports—#10443

Dear Mr. Wilson: You have asked whether, under the requirements of Joint Rule 30 and Assembly Rule 68.8, a conference committee report that is submitted to the Assembly Desk on a Tuesday and is both in print and noticed in the Assembly Daily File on the next day, Wednesday, may be taken up by the Assembly on Thursday of the same week, assuming that each day to which your question refers is a legislative day.

Rule 30 of the Joint Rules of the Senate and Assembly for the 1997–98 Regular Session¹ (hereafter Joint Rule 30) reads, in pertinent part, as follows:

"30. Upon submission of any report of a committee on conference recommending that the bill be further amended, the bill shall be reprinted incorporating the amendments recommended by the conference committee. The consideration of the report of a committee on conference shall not be in order until the bill, in the form recommended by the report of the committee on conference, has both been in print and been noticed in the Daily File for not less than one legislative day.

Rule 68.8 of the Standing Rules of the Assembly for the 1997–98 Regular Session² (hereafter Assembly Rule 68.8) reads as follows:

"68.8. No conference report may be heard by the Assembly until it has been in print for two days prior to being taken up by the house."

Under Joint Rule 30, a conference committee report may not be heard by the Assembly until the report has both been in print and been noticed in the Daily File for not less than one legislative day. Under Assembly Rule 68.8, a conference committee report may not be heard by the Assembly until it has been in print for two days prior to being taken up by the house.

A legislative day is defined as the period beginning with the convening of at least one house of the Legislature in session and extending until the adjournment of that session (see *Mason's Manual of Legislative Procedure* (1989), Sec. 271; hereafter *Mason's Manual*).

However, no provision of the Joint Rules or Assembly Rules for the 1997–98 Regular Session, or of *Mason's Manual*, prescribes how a period of one or more "days" is to be calculated. Section 10 of the Civil Code, Section 12 of the Code of Civil Procedure, and Section 6800 of the Government Code all provide that "[t]he time in which any act provided by law is to be done is computed by excluding the first day, and including the last, unless the last day is a holiday, and then it is also excluded." Thus, in the computation of a period of time after a particular event, the generally accepted rule is that the day of the "event is excluded and the computation of time is commenced on the following day" (*Kuhs* v. *Superior Court* (1988) 201 Cal.App.3d 966, 972, quoting *Ziganto* v. *Taylor* (1961) 198 Cal.App.2d 603, 607). Any fraction of a day is deemed a day (*People* v. *Smith* (1989) 211 Cal.App.3d 523, 526, quoting *Municipal Imp. Co.* v. *Thompson* (1927) 201 Cal. 629, 632).

Under these provisions, when a conference committee report is first in print and noticed in the Assembly Daily File on a Wednesday, that day is excluded in computing the number of days the report is in print and noticed in the File, but any fraction of any subsequent day is included. Thus, the first day that is included in computing the number of days the report is in print and noticed in the File is Thursday; the second day is Friday. In this scenario, a conference committee report first in print and noticed in the Assembly Daily File on Wednesday could not be taken up by the Assembly on the following day. While the requirement of Joint Rule 30, that a conference committee report may not be heard by the Assembly until the report has both been in print and been noticed in the Daily File for not less than one legislative day, is met by the report being in print and noticed in the Daily File on Thursday, the requirement of Assembly Rule 68.8, that a conference report may not be heard by the Assembly until it has been in print for two days, is not met until Friday.

We are informed that the practice of the Assembly has been to calculate time under Joint Rule 30 and Assembly Rule 68.8 accordingly, so that a conference committee report that is first in print and noticed in the Assembly Daily File on a Wednesday is not taken up by the Assembly until that Friday at the earliest. It is our understanding that this practice has been consistent, and is a precedent that governs the house unless the house decides otherwise (see *Mason's Manual*, Sec. 39).

However, as a legislative body, each house of the Legislature possesses the power to govern its internal affairs, including the adoption and revision of rules for that purpose (see *In re Collie* (1952) 38 Cal.2d 396, 398). Subdivision (a) of Section 7 of Article IV of the California Constitution states that each house of the Legislature "shall choose its officers and adopt rules for its proceedings."

The difference between a statute and a rule adopted by the Legislature to govern its procedures has been discussed by the Court of Appeal for the Third Appellate District in *People's Advocate, Inc.* v. *Superior Court* (1986) 181 Cal.App.3d 316, 325, as follows:

"The subjects of statutes are categorically different from the subjects of the rule-making powers of article IV, sections 7 and 11 [of the California Constitution]. The subjects of statutes are laws. (Art. IV, sec. 8: 'The Legislature may make no law except by statute . . .'; [citation].) The kinds of rules and principles which are subsumed under the statutory 'law' are addressed to the world *outside* the Legislature. [Citations.] Conversely, the internal rules of the Legislature do not have the force of law except as they may bind the house which adopted them. [Citation.] Since the subjects of statutory laws and rules of internal procedure *categorically* differ, a statute may not control a rule of internal proceeding." (Emphasis in original.)

The holding in *People's Advocate, Inc.* v. *Superior Court,* supra, is consistent with *Mason's Manual,* Sections 3, 22, and 71. In particular, Paragraph 6 of Section 3 provides that "[u]nder the power to determine the rules of its own procedure, each house of the legislature has the power to determine how it will handle conference committee reports including a minority report."

Thus, a house of the Legislature may, under its rulemaking authority, determine for itself how a day is to be computed for purposes of Joint Rule 30 and Assembly Rule 68.8. The house may reject the statutory rule that the time in which an act is to be done is computed by excluding the first day and including the last, and may decide, for example, to include the first day in computing the time. If the Assembly chooses to compute time in this manner, the legislative day after the legislative day on which the report is both in print and noticed in the Assembly Daily File meets the requirements not only of the one legislative day provision of Joint Rule 30, but also of the two-day in print provision of Assembly Rule 68.8 and, in that event, the Assembly properly may take up the report on the second legislative day.

To summarize, if the Assembly follows the statutory rule, and its own past practice, that the time in which an act is to be done is computed by excluding the first day and including the last, a conference committee report that is submitted to the Assembly Desk on a Tuesday and is both in print and noticed in the Assembly Daily File on the next day, Wednesday, may not be taken up by the Assembly on that Thursday under the requirements of Joint Rule 30 and Assembly Rule 68.8 because it will not have been in print for two days. On the other hand, the Assembly may elect to revise its practice regarding that computation so as to include the first day in computing the time requirements of Joint Rule 30 and Assembly Rule 68.8, in which event the time requirements of both rules will be met on the legislative day after the legislative day on which a conference committee report is both in print and noticed in the Assembly Daily File and, consequently, a report that is submitted to

the Assembly Desk on a Tuesday and is in print and noticed in the Assembly Daily File on the next day, Wednesday, may be taken up by the Assembly on Thursday of the same week.
