Dear Mr. Speaker,

On July 11, 2002, I received from Legislative Analyst Elizabeth G. Hill an updated five-year General Fund projection. I am deeply concerned about her projections as they make it very clear this Legislature has yet to come up with a fiscally responsible, balanced budget.

Specifically, the Legislative Analyst Office estimates that under the 2002–03 Budget Act, "annual operating shortfalls would increase by roughly \$2 billion per year relative to the May Revision." This, according to the LAO, "largely reflects the restoration by the Legislature of ongoing spending reductions proposed by the Governor in the areas of health, social services, and local government."

According to the LAO report:

. . . annual shortfalls would grow from \$9.8 billion in 2003–04 to \$12.3 billion in 2004–05, before declining in subsequent years to \$8.7 billion by 2007–08.

Put simply, California will—through fiscal year 2007–08—have a total operating deficit of \$51.6 billion. The chart below, taken from the LAO report, shows the annual operating deficit over the next six budget periods if the current 2002–03 Budget Act is adopted.

#### According to the LAO:

The large operating shortfalls that occur under the May Revision and AB 425 reflect the large amount of one-time or limited-term solutions used to cover the budget shortfall in 2002–03. Examples include the securitization of tobacco settlement receipts (one-year benefit), loans from transportation funds (one-year benefit), the one-year increase in the vehicle license fee, the two-year suspension of the net operating loss deduction for businesses, and the two-year deferral of debt-service payments related to the Treasurer's debt restructuring plan.

The LAO further stated that there are approximately \$600 million in loans "for which no specific repayment dates were established. These other loans could further add to out-year pressures both under the May Revision and under AB 425."

Clearly, the Legislature needs to craft real solutions to the structural budget identified by the Legislative Analyst.

#### SPECIAL CEREMONY HONORING RETIRING MEMBERS

At 9:45 a.m., a special ceremony was convened to honor Members retiring from the California State Assembly.

Without objection, family members and special guests of honorees were permitted on the Floor of the Assembly.

The following resolution was read:

#### House Resolution No. 73

By Assembly Member Wesson

*Relative to commending the Honorable David G. Kelley.* 

WHEREAS, The tenure of the Honorable David G. Kelley with the California State Assembly is drawing to a close following a total of 24 years in the California State Legislature, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendations of the people of the state; and

WHEREAS, Assembly Member David Kelley was elected to the California State Assembly in 2000 to represent the 80th Assembly District; prior to that, he served eight years in the California State Senate and, prior to term limits, served 14 years in the Assembly, where he was first elected in 1978; and

WHEREAS, Dave Kelley is known in both the Assembly and the Senate as one of the state's most knowledgeable and key water leaders, including fresh water, water conservation, water reclamation, water planning, and water transfers; and

WHEREAS, To that end, and with regard to fresh water, he was key to the success of the San Diego County Water Authority (SDCWA), Imperial Irrigation District (IID), and Metropolitan Water District of Southern California agreement on the transfer of agricultural water from IID to SDCWA, and by virtue of introducing and seeing signed into law his Senate Bill 1082 in 1997, he became the father of

California's 4.4 Plan, which will reduce Southern California's dependence on the Colorado River without leading to a net loss of water; and

WHEREAS, In the arena of water conservation, he carried legislation that established water efficiency standards for commercial washing machines, advocated the use of "reclaimed" or "recycled" water throughout the state, created an office within the Department of Water Resources to deal with water reclamation and the promotion of the use of reclaimed water statewide, and worked tirelessly for several years with former Legislator and Judge, Gordon Cologne, on this unique issue of reusing water and saving our precious drinking water; and

WHEREAS, Assembly Member Kelley was instrumental in having signed into law legislation relating to geothermal energy and other alternative energy sources, and in the arena of environmental resource protection, he established the Salton Sea Authority, an entity designed to manage and protect the resources of the Salton Sea, which is located totally within his district; and

WHEREAS, In 1993 Senator Kelley was appointed by the Senate Rules Committee to serve as a member of the Library Construction and Renovation Bond Act Board, in which capacity he obtained bond moneys to build much-needed libraries in Cathedral City and Rancho Bernardo; and

WHEREAS, Over a three-year period, Senator Kelley obtained enough moneys through the Budget Bills to build a park that was sorely needed to assist the at-risk youth of Calexico, a poor community in Imperial County; and

WHEREAS, He carried legislation and worked directly with CalTrans from the time he was first elected until 2001 to get improvements on Highway 86, a roadway named "The Killer Highway," and he was successful in turning a dangerous two-lane road into a four-lane highway through two counties in his district; and

WHEREAS, He secured funding for the University of California's Exotic Pest Research Facility at the University of California, Riverside, carried and supported many pieces of legislation dealing with the myriad of issues surrounding California's agricultural interests, including water, pesticides, integrated pest management, taxes on farm implements, and the Williamson Act, and introduced legislation that was signed into law that created "California Gold," the royalty fees from which go to the State General Fund, and legislation that established sisterhood status between California and Baja California, Mexico; and

WHEREAS, In 1996 Senator Kelley was appointed by the Senate Rules Committee to Chair a Senate Working Group for the Proposed Western Center on Archaeology and Paleontology, a research and teaching facility suggested for construction at the Domenigoni Valley Reservoir Site in Riverside County, and he worked relentlessly to secure funding to see a Western Center for Archaeology and Paleontology established; and

WHEREAS, Born and raised in Riverside County, Assembly Member Kelley graduated from California State Polytechnic University, San Luis Obispo, majoring in citrus fruit production, served during the Korean Conflict as a pilot in the United States Air Force, and

has been a successful citrus rancher for more than 40 years in the Hemet area, where he has been intensely involved in agricultural organizations and civic organizations; and

WHEREAS, Dave Kelley and his wife, Brigitte, are the parents of four grown children, Sharon Haupt, Bridget Kelley, Margi Valine, and Ken Kelley, and devoted grandparents of nine grandchildren; and

WHEREAS, Through his public service activities he has made a significant impact on the people of the 80th Assembly District and throughout the state, and he will be greatly missed by those individuals with whom he has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That the Members express their commendations and appreciation to their colleague, the Honorable David G. Kelley, for his outstanding record of dedicated service to his constituents and to all of the people of California, and convey to him best wishes for every success in his future endeavors.

Relative to commending the Honorable Dennis A. Cardoza.

WHEREAS, The Honorable Dennis A. Cardoza is drawing to a close his tenure with the California State Assembly following six years of exemplary service, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendations of the people of the state; and

WHEREAS, Elected in 1996 to the first of three very effective terms in the California State Assembly representing residents of the 26th District, Dennis Cardoza, as a freshman member of the Assembly, chaired the Agriculture Committee and, more recently, served as Chairman of the powerful Rules Committee; and

WHEREAS, He also was a member of the Budget and Governmental Organization Committees and Chair of the Select Committee on the Department of Motor Vehicles and Select Committee on the Development of the tenth campus of the University of California; and

WHEREAS, Assembly Member Cardoza helped forge the Moderate Caucus of Democrats, and he was honored by a wide group of Valley organizations for his efforts to cut taxes, help family farms, and promote education and safety issues for children; and

WHEREAS, He was twice named Legislator of the Year by the California Sheriff's Association, was honored by the University of California as Legislator of the Year for his work on behalf of the University of California, Merced, and was selected as the 2001 Legislator of the Year by the Small Business Roundtable and Small Business Association; and

WHEREAS, A champion of common-sense solutions to the challenges facing twenty-first century California, he authored the original Vehicle License Fee Reduction (VLF), one of the largest tax cuts ever to pass the Legislature, which has returned \$5 billion to California vehicle owners through significant and ongoing reductions of license fees; and

WHEREAS, He has been a strong and effective advocate for the families of men and women who served in our country's hour of need, and he has been a great friend of veterans of all conflicts and wars, working on their behalf as a member of the Governor's Commission on Veteran's Homes; and

WHEREAS, During his freshman term, Assembly Member Cardoza wasted no time in authoring urgency legislation to provide tax relief for people hard hit by the ruinous losses resulting from the devastating floods of 1997, and never forgetting his roots, he crafted many pieces of legislation to stimulate the local economy, and worked to ensure small communities in his district were not left out of the digital revolution; and

WHEREAS, Assembly Member Cardoza was untiring in his efforts to establish a University of California campus in the Central Valley, with branches already operating in Fresno, Bakersfield, and Modesto; and

WHEREAS, Despite his quick rise to a prominent position in the Assembly, Dennis Cardoza never forgot his agriculture roots; his grandparents emigrated from the Azores Islands of Portugal in the first part of the twentieth century to farm the rich Merced County soil, and the Cardoza family raised dairy cattle and grew sweet potatoes, almonds, watermelons, wheat, oats, and alfalfa; and

WHEREAS, Assembly Member Dennis Cardoza lives in Atwater with his wife, Dr. Kathleen McLoughlin, and their three children, Joey, Brittany Mari, and Elaina; and

WHEREAS, Through his public service activities he has made a significant impact on the people of the 26th Assembly District and throughout the state, and he will be greatly missed by those individuals with whom he has been associated; now, therefore, be it
