Relative to commending the Honorable Phil Wyman.

WHEREAS, The tenure of the Honorable Phil Wyman with the California State Assembly is drawing to a close following a total of more than 17 years of exemplary service with the California State Legislature, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendations of the people of the state; and

WHEREAS, Phil Wyman's career in the California State Legislature dates back to 1978 when he won election to the Assembly, and in the 14 years following he distinguished himself as Republican Whip, Chairman of the Assembly Constitutional Amendments Committee and the Assembly Republican Policy Committee, Vice Chairman of the Assembly Republican Caucus, the Assembly Water, Parks & Wildlife Committee, the Assembly Economic Development Committee, and the Assembly Agriculture Committee, and as a member of the Little Hoover Commission and the Joint Legislative Committee on the State's Economy; and

WHEREAS, During his tenure in the Assembly, he fought successfully to reinstate the death penalty, to repeal the inheritance tax, to enact the Nursing Home Reform Act, and to extend California's D.U.I. statutes to cover drugged as well as drunken drivers; and

WHEREAS, As a stalwart supporter of the unborn, Phil Wyman authored California's Parental Consent Statute; he also authored legislation to equalize categorical school district funding, and presented testimony before the U.S. Supreme Court in the successful defense of Proposition 13; and

WHEREAS, In a special election in 1993, he won a seat in the California State Senate, where he became a member of the Senate Agriculture & Water Resources Committee, Senate Veterans Affairs Committee, Senate Banking, Commerce and International Trade Committee, Energy and Public Utilities Committee, and Senate Member of the Joint Committee on Legislative Audit; and

WHEREAS, During his tenure in the Senate, he became renowned as the Senate author of "Three Strikes and You're Out," which was signed into law in March 1994, and Senate author of the School Uniform Law (Senate Bill 1269), which was signed into law in August 1994; and

WHEREAS, In 2000 the voters of the 34th Assembly District returned Phil Wyman to the State Assembly, where he provided far-reaching leadership as Senior Republican Whip, Vice Chairman of the Assembly International Trade and Intergovernmental Relations Committee and the Business & Professions Committee, and as a member of the Banking & Finance Committee, Water, Parks & Wildlife

Committee, Jobs, Economic Development and the Economy Committee, Veterans Affairs Committee, Higher Education Committee, and Select Committee on the Aerospace Industry; and

WHEREAS, A native of Kern County and veteran of the United States Air Force, Phil Wyman graduated from the University of California, Davis, with a Bachelor of Arts degree in political science and minor in agricultural economics and with a Juris Doctor from the University of the Pacific, McGeorge School of Law, as well as two years of graduate studies in International Law Study at the Ateneo de Manila University, Manila, in the Philippines; and he is a member of the State Bar of California and the Supreme Court of the United States Bar; and

WHEREAS, Phil Wyman is founder of the Philippine Astronomical Society, and was awarded the “Padre Faura Astronomy Medal” for the advance of science in the Philippines; he is a member of the American Legion and numerous chambers of commerce, and along with his brother, Ted Wyman, manages the Wyman Family Ranch and Campground in Tehachapi, California; and

WHEREAS, Phil Wyman and his wife, Lynn, are the proud parents of three children, including Andrea Wyman Beacom, married to their son-in-law Clint Beacom, Elizabeth Wyman, a student at Point Loma Nazarene University, and David Wyman, a student at Tehachapi High School; and

WHEREAS, Through his public service activities Phil Wyman has made a significant impact on the people of the 34th Assembly District and throughout the state, and he will be greatly missed by those individuals with whom he has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That the Members express their commendations and appreciation to their colleague, the Honorable Phil Wyman, for his outstanding record of dedicated service to his constituents and to all of the people of California, and convey to him best wishes for every success in his future endeavors.

Speaker Wesson appointed Assembly Members Ashburn, Cox, Kelley, La Suer, Mountjoy, and Papan as a Select Committee on Escort to escort Assembly Member Phil Wyman, his wife Lynn Wyman, and their family to the Rostrum, whereupon a resolution and special plaque was presented by Speaker Wesson expressing the best wishes of all Members of the Assembly as he departs the California State Assembly.

House Resolution No. 77

By Assembly Member Wesson

Relative to commending the Honorable Tony Cardenas.

WHEREAS, The tenure of the Honorable Tony Cardenas with the California State Assembly is drawing to a close following six years of exemplary service, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendations of the people of the state; and

WHEREAS, Assembly Member Cardenas was elected to the California State Assembly in 1996 to represent the 39th District, and during his three terms he became a voice for many important issues that affect families in the San Fernando Valley and throughout California; and

WHEREAS, As a child, Assembly Member Cardenas attended public schools and graduated with a degree in electronic engineering from the University of California at Santa Barbara, where he was on the Dean's Honor List, and upon graduation, he worked at Hewlett Packard; he later owned and was president of a real estate company in the San Fernando Valley; and

WHEREAS, During his first term in the Assembly, Assembly Member Cardenas created an aggressive legislative agenda to cut bureaucratic red tape and he authored legislation to require Medi-Cal to approve or deny treatments within three days, to reform the state's professional engineer licensing board, to close loopholes in the state's seatbelt laws, to increase the penalties on repeat drunk drivers, to require background checks on employees at long-term care facilities, and to reform the state lottery to ensure that more money was spent on textbooks and classroom materials; and

WHEREAS, In his second term, Assembly Member Cardenas' legislative agenda focused on children and public education in that he authored legislation to create a priority point system that gave overcrowded and landlocked schools priority in obtaining state school construction funds, to create statewide standards for high school honors courses, to facilitate the construction of more child care centers, to conduct an audit of the state's lead poisoning prevention programs, and to review the manner in which prenatal nutrition information and cervical cancer screening information is distributed to women, and he authored the Schiff-Cardenas Crime Prevention Act, the nation's most comprehensive juvenile crime prevention and intervention program; and

WHEREAS, In his last term, Assembly Member Cardenas was named Chairman of the Assembly's Budget Committee, and in that role, helped achieve efforts to cut administrative budgets of state departments for failure to complete reports, to fund the creation of before and after school programs, to expand funding for community health clinics and trauma centers, to increase funding to eliminate school bus pollution, and to increase funding for outreach programs at California's universities; and

WHEREAS, During his tenure in the Assembly, Assembly Member Cardenas served the people of California as a member of the Budget, Elections, Reapportionment and Constitutional Amendments,

Governmental Organization, Appropriations, Banking, Transportation, Natural Resources, and Utilities and Commerce Committees, and as Chairman of the Select Committees on California Indian Nations and Juvenile Justice, Vice Chairman of the Joint Legislative Budget Committee; and

WHEREAS, A strong voice for children, Assembly Member Cardenas secured \$30 million in after-school programs, pioneered the state's first before-school program, and obtained \$5.5 million to house the Los Angeles Children's Museum in the San Fernando Valley; he also teamed up with Major League Baseball to secure \$2.3 million for the nation's only Major League Baseball Youth Academy, located in the Valley; and

WHEREAS, As an advocate for safer neighborhoods, Assembly Member Cardenas fought to ensure children stay off the streets and out of gangs, and he engineered the nation's most comprehensive juvenile crime prevention legislation, and provided more than \$241 million per year for Los Angeles County law enforcement, the COPS program, and prevention/treatment programs for youth; and

WHEREAS, He also fought for cleaner, safer air, secured \$20 million to purchase smog-free mail carrier trucks, authored legislation to retrofit the state's fleet of diesel schoolbuses, and obtained \$15 million in the State Budget to clean and beautify urban parks; and

WHEREAS, Assembly Member Cardenas knows first hand the hard work and dedication it takes to run a business; he brought the first Small Business Development Center to the San Fernando Valley to provide guaranteed loans for local business owners, and helped to create the Home Business Tax Exemption so that creative artists such as graphic designers, writers, and actors obtain tax relief while working from their homes; and

WHEREAS, In recognition of his hard work and success in the California State Assembly, Assembly Member Cardenas has received numerous awards, including the Legislator of the Year Award from the California Hispanic Chamber of Commerce, the award for Special Recognition for Legislative Leadership by the California Association for Bilingual Education, the High Tech Legislator of the Year award from the American Electronics Association, and humanitarian awards from the Valley Family Center and the City of San Fernando; and

WHEREAS, Assembly Member Cardenas resides in Panorama City with his wife Norma, her daughter Vanessa, and their children Christian, Andres, and Alina; and

WHEREAS, Through his public service activities, Assembly Member Cardenas has made a significant impact on the people of the 39th Assembly District and throughout the state, and he will be greatly missed by those individuals with whom he has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That the Members express their commendations and appreciation to their colleague, the Honorable Tony Cardenas, for his outstanding record of dedicated service to his constituents and to all of the people of California, and convey to him best wishes for every success in his future endeavors.
