Mr. Wilson: This letter is to clarify the intent of Assembly Bill 426, as passed by the Assembly on July 23, 2001. Amendments to Assembly Bill 426 adopted by the Senate on July 21, 2001, and included in the enrolled bill, added Sections 8 and 9, amending Sections 20543 and 20544 of the Revenue and Taxation Code. The intent of Sections 8 to increase the benefits provided under Gonsalves-Deukmejian-Petris Senior Citizens Property Tax Assistance Law by permanently increasing the computed amount of the benefit by 45 percent. Technical drafting errors in Sections 8 and 9, however, resulted in language that applies the 45 percent increase to the qualifying household income levels for the program, rather than to the amount of benefits. The Senate floor analysis of the bill explained the intended action correctly, as "a permanent increase in benefits of 45 percent over the current law level." Likewise, the Assembly floor analysis noted that "the intent of the Senate amendments is to increase these payment amounts by 45 percent." Assembly Bill 440, as enrolled, appropriates \$75 million from the General Fund for increased benefit costs in 2001–02, consistent with the intent of AB 426. The Legislature intends to achieve the original intent of Assembly Bill 426 by enacting corrective legislation as soon as possible.
