SENATE BILL NO. 18—An act to amend Sections 80010, 80100, 80110, 80122, 80132, 80134, and 80200 of, and to add Section 80131 to, the Water Code, relating to electric power, making an appropriation therefor, and declaring the urgency therefor, to take effect immediately.

SENATE BILL NO. 84—An act to add Section 25403.8 to the Public Resources Code, and to amend Section 21800 of the Vehicle Code, relating to energy, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.

SENATE BILL NO. 41—An act to amend Section 739 of, and to add Section 739.2 to, the Public Utilities Code, relating to public utilities, and declaring the urgency thereof, to take effect immediately.
