Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report concerning resident safety at developmental centers operated by the California Department of Developmental Services (department).

This report concludes that the department needs to improve its oversight of the safety of residents housed and cared for in its developmental centers. Our review found that health care staff did not always provide timely notification of incidents to the department's Office of Protective Services (OPS), and that OPS law enforcement personnel did not consistently follow established procedures for investigations of alleged resident abuse. Specifically, OPS often failed to collect written declarations from suspects and witnesses, take photographs of crime scenes or alleged victims, and attempt to interview alleged victims, particularly residents said to be nonverbal.

Frequent turnover in OPS management has contributed to a lack of action in addressing longstanding problems, many of which were raised in a 2002 Office of the Attorney General's report. These problems include a lack of required specialized training for OPS personnel to effectively work with residents, high vacancy rates within OPS, and OPS's lack of a cohesive recruiting plan. Furthermore, both OPS and the department's health care staff have experienced excessively high amounts of overtime, caused by staff scheduling issues and hiring freezes.

Finally, our review of the California Department of Public Health's (Public Health) oversight responsibilities has shown that it does not consistently perform all of its required duties, such as promptly performing follow-ups on certification surveys and performing state licensing surveys on time, if at all. Public Health also does not consistently conduct prompt investigations for incidents it classifies as less serious. Furthermore, because Public Health has not prepared required annual reports regarding its enforcement activities, the effectiveness of these activities on maintaining quality of care in health care facilities, including the developmental centers, remains uncertain.

Members of the Assembly: As authorized by California Government Code, Section 8546.5, the California State Auditor (state auditor) presents this audit report designating Covered California's establishment of a health insurance exchange as a high-risk issue in California. To implement provisions of the federal Patient Protection and Affordable Care Act (Affordable Care Act), state law required Covered California to create and operate for the first time in California a health insurance exchange, which is a competitive insurance marketplace in which individuals and small businesses will be able to purchase qualified health plans (QHPs) starting on October 1, 2013.

This report concludes that although Covered California has made great strides in implementing key federal and state requirements pertaining to the exchange's establishment and operations, critical work and some concerns remain. Specifically, Covered California's financial sustainability is wholly dependent on enrollment in QHPs offered through the exchange. Recognizing this, Covered California has worked diligently and collaboratively with various stakeholders, including the California Department of Health Care Services and the Management Risk Medical Insurance Board to streamline eligibility and enrollment as well as to promote and support enrollment. Even so, future enrollment is unpredictable and is based on market factors outside of Covered California's control. Consequently, enrollment in the exchange and the financial sustainability of Covered California will need to be monitored. Additionally, to ensure that its QHPs comply with Affordable Care Act requirements, Covered California needs to develop monitoring, recertification, and decertification procedures for QHPs offered through the exchange.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor (state auditor) presents this audit report concerning the intervenor compensation program (program) administered by the California Public Utilities Commission (commission).

This report concludes that despite administrative weaknesses, the commission has generally awarded compensation to intervenors—individuals and groups that represent the interests of utility ratepayers—in accordance with state law. We found that the commission has a process in place to ensure that intervenors meet the necessary statutory requirements before it awards compensation for work conducted during regulatory proceedings. In addition, the commission has a robust process for determining whether the costs and expenses intervenors claim are reasonable, as state law requires. However, we determined that the commission only issued 6 percent of its intervenor compensation decisions during 2008 through 2012 within the 75-day deadline required by state law. The commission has also not issued guidance to its staff or utilities on how to calculate interest appropriately for intervenor claim decisions issued after the 75-day deadline. The lack of formal guidance has led the commission to employ a flawed interest computation methodology, resulting in miscalculations and, ultimately, overpayments of interest on awards. Of the \$42,000 in interest that the commission paid for the 10 largest interest payments we reviewed, we estimate that it overpaid \$40,000.

Further, we noted some areas in which the commission could do more to ensure that it appropriately compensates intervenors. Specifically, state law requires the commission to take into consideration the market rates paid to persons of comparable training and experience who offer similar services. However, the commission has acknowledged it has faced difficulties in fully complying with the requirement and that a comprehensive market rate study is necessary to ensure compliance with the law. In addition, we found that the commission lacks formal procedures to verify the qualifications of intervenors appearing in proceedings. Despite these weaknesses, we found that the program fulfills a fundamental part of its purpose, which is to encourage the effective and efficient participation of all groups that have a stake in the public utility regulation process. We found that organizations participating in the program represented a broad array of interests, including environmental concerns, low-income and minority ratepayers, and ratepayers in a specific geographic region.
