Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning our review of the implementation, application, and efficacy of red light camera programs statewide.

This report concludes that red light cameras have contributed to a reduction of accidents; however, our review of a sample of seven local governments found weaknesses in the way they are operating their programs that make them more vulnerable to legal challenge. Specifically, we found that the local governments we reviewed need to more rigorously supervise their respective vendors to exercise and maintain control of their programs.

Furthermore, we could not always determine if local governments followed the best practice of first addressing any needed engineering improvements to the intersections they designated before installing the red light cameras. In addition, four of the seven local governments in our sample avoided placing cameras at dangerous intersections along state-owned highways because of the delay involved in obtaining state permission. Moreover, most would use photographs as evidence in criminal proceedings even though it would appear to conflict with the law governing the program.

We also found that the local governments in our sample have generally followed the California Department of Transportation's required yellow light time interval standards. Finally, only two of the seven local governments we reviewed have generated significant revenue from their red light camera programs.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the University of California's (university) partnership agreement. This report concludes that although the university's partnership agreement contains measurable targets for some of the objectives, it does not contain such targets for others. Specifically, we found that of the 22 objectives in the partnership agreement, only 9 contain outcomes with quantifiable and clear targets to measure improved performance, and 13 do not. Thus, the university's ability to demonstrate its success in using state funds to achieve the partnership agreement's objectives is limited. Additionally, the university's expenditures for support salaries made out of its general operating funds increased at a greater rate than its expenditures for academic staff salaries within instruction, research, and public service between 1997 and 2001-two years before and three years after the partnership agreement went into effect. Only 44 percent of its increase in salary expenditures during this time related to these academic salaries, while 56 percent related to support staff salaries.

Further, certain factors have an impact on the 4.8 primary course-to-faculty ratio the university agreed to maintain as part of the partnership agreement. For example, we found that 13 percent of the primary courses taught by regular-rank faculty had enrollment of two students or fewer. In addition, although the university reports the workload of regular-rank faculty in its annual report to the Legislature, it does not address the workload of non-regular-rank faculty and miscellaneous instructors. These individuals teach a combined total of 46 percent of the university's primary courses. Because the university does not disclose workload ratios for all faculty and miscellaneous instructors, the Legislature and governor may not have a complete picture of how the workloads affect the university's ability to meet the objectives of the partnership agreement.

WHEREAS, The tenure of the Honorable Anthony Pescetti with the California State Assembly is drawing to a close following four years of exemplary service, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendations of the people of the state; and

WHEREAS, Elected to the California State Assembly in 1998 and re-elected to office in 2000, Assembly Member Pescetti represents the 10th Assembly District, which covers portions of Sacramento and San Joaquin counties, and includes the cities and communities of Sacramento, Elk Grove, Rancho Cordova, Gold River, Galt, Rancho Murieta, and Lodi; and

WHEREAS, Known for his tireless work in representing his district, Assembly Member Pescetti is credited with hosting a special hearing of the Utilities and Commerce Committee in Elk Grove, and later introducing Assembly Bill 2198 to encourage local phone service providers to improve their infrastructure, bringing about a pay raise for state workers in 1999, securing millions for transportation projects and a new senior center in the Sacramento area and police stations in Galt and Lodi, and introducing three measures to support cityhood efforts in Elk Grove and Rancho Cordova; and

WHEREAS, A strong advocate of education, Assembly Member Pescetti visited all 104 public K–12 schools in his district during his tenure and introduced legislation in 2000 to increase education funding by means of block grants to school districts—a key feature of the final budget agreement that year; and

WHEREAS, He was an effective leader in the height of the energy crisis, helping craft numerous measures that became key components of the Legislature's response to that crisis, and he became the first lawmaker to propose a broad solution to the energy crisis when he proposed amendments to Assembly Bill 2198 to shore up utility finances; and

WHEREAS, Assembly Member's Pescetti's vast experience in the energy industry earned him a leadership role in the Legislature with respect to energy issues, and he brought distinction to himself as Vice Chairman of the Assembly Utilities and Commerce Committee and the Special Committee on Energy, Costs, and Reliability; and

WHEREAS, In addition to his experience at SMUD, he was Chief of Staff for the Division of the State Architect, a position to which he was appointed by Governor George Deukmejian and re-appointed by Governor Pete Wilson; and

WHEREAS, Assembly Member Pescetti has been active in the community as a member of the San Juan Fair Oaks Lions Club, Folsom Area Economic Development Committee, Rancho Cordova Chamber of Commerce, Elk Grove Chamber of Commerce, Galt Economic Development Task Force and Emerging Technology Institute, and he has been a member of the board of directors for the nonprofit organization Women Escaping a Violent Environment (W.E.A.V.E.); and

WHEREAS, Assembly Member Pescetti and his wife, Kathy, are residents of Rancho Cordova, and they are the proud parents of two children, Sarina and Anthony, Jr.; and

WHEREAS, Through his public service activities he has made a significant impact on the people of the 10th Assembly District and throughout the state, and he will be greatly missed by those individuals with whom he has been associated; now, therefore, be it

WHEREAS, The tenure of the Honorable Dick Dickerson with the California State Assembly is drawing to a close following four years of exemplary service, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendations of the people of the state; and

WHEREAS, Dick Dickerson was elected to the California State Assembly in 1998 to represent the 2nd District, which includes the Northern California counties of Colusa, Glenn, Shasta, Siskiyou, Sutter, Tehama, Trinity, and parts of Butte and Yolo; and

WHEREAS, A former 30-year law enforcement officer, Dick Dickerson brought common sense experience to office and became a voice for crime victims during his first term as Vice Chairman of the Assembly Committee on Public Safety; and

WHEREAS, Dick Dickerson served as Vice Chair of the Assembly Committee on Water, Parks & Wildlife during both of his terms in the Assembly, and in negotiations with the Governor during his first term, Assembly Member Dickerson secured \$20 million to complete studies on above-ground water storage as a major concession for the legislative passage of the Water Bond; and

WHEREAS, Dick Dickerson has been a staunch supporter of the proposed Sites Reservoir within Colusa County and raised awareness among the Members of the Legislature that additional storage is needed to meet the water supply needs of a growing state, and along with the Northern California Water Association, he was successful in pushing forward the audit of California's land acquisition policies; and

WHEREAS, During his two consecutive terms in the Assembly, Dick Dickerson retained a seat on the Assembly Committee on Natural Resources, one that is so essential to the region's way of life, and he has authored legislation to remove vegetation that has become hazardous fuel so it can be used as energy-producing biomass; and

WHEREAS, As a member of the Assembly Committee on Budget specializing in the resources area, Assembly Member Dickerson obtained \$4.58 million in the budget act for the California Department of Forestry and the Department of Corrections to pay for the reactivation with nonviolent inmates of fire crews af 17 Conservation Camps throughout California, and these inmates have been utilized for assistance with fighting fires, energy flood work, and environmental restoration, with seven of these camps in Northern California and five located within Assembly Member Dickerson's district; and

WHEREAS, Sitting on the most committees of any other Republican member, Dick Dickerson's committee assignments throughout his term in office include Chairman of the Assembly Committee on Veterans Affairs, Vice Chair of the Committee on Water, Parks & Wildlife, and member of the Natural Resources, Public Safety, Budget, Governmental Organization, Insurance, Health, and Energy Costs & Availability committees; and

WHEREAS, In the wake of the September 11 tragedy, he was appointed to the Task Force on Terrorism; and

WHEREAS, Dick Dickerson has served on nine select committees, including CALFED, Juvenile Justice, Air & Water Quality, California Indian Nations, California Wine, Protection of Inland Waterways, Rural Economic Development, Department of Motor Vehicles, and Gun Violence; and

WHEREAS, A total of 20 bills authored by Dick Dickerson have been enacted during his term, and the 2001 legislative year was particularly successful, with seven bills signed into law by Governor Gray Davis, including legislation to increase the presence of deputies and firefighters on our streets and in our communities, to enhance the protection of children from molesters, and to provide assistance for olive growers in their battle against the olive fruit fly; and also pursuant to legislation authored by Assembly Member Dickerson a rice industry certification system was created that is allowing California farmers to compete globally, and local transportation dollars are now being returned to counties that incur savings on their construction projects; and
