Dear Mr. Speaker: I wish to publish this letter of legislative intent in the Assembly Daily Journal relative to my AB 1284.

AB 1284 allows the Public Utilities Commission to defer or waive Cost Responsibility Surcharges (CRS) for a narrow range of economically distressed customers, whose Direct Access energy contracts were involuntarily terminated at the height of the energy crisis. This bill only allows the deferral or waiver in order to mitigate the "certain and imminent closure" of a customer's plant or facility.

"certain and imminent closure" of a customer's plant or facility.

Among other criteria, AB 1284 defines a "qualifying direct transaction customer" as a plant or facility that was involuntarily returned to the investor-owned utility (IOU) for electrical service after February 1, 2001, and the plant or facility entered into a new Direct Access contract and submitted a direct access service request (DASR) within ninety days following involuntary termination.

For purposes of these sections, it is the author's intent that the date of involuntary termination is based on the end of the contractual relationship between the customer and the electric service provider as evidenced by the termination date in the provider's notification to the customer that its contractual relationship was terminated. It is the author's intent that SierraPine's Rocklin Division meets all criteria set forth in the bill.
