SPECIAL CEREMONY HONORING RETIRING MEMBERS

At 11:37 a.m., a special ceremony was convened to honor Members retiring from the California State Assembly.

Without objection, family members and special guests of honorees were permitted on the Floor of the Assembly.

House Resolution No. 78

By Assembly Member Wesson

Relative to commending the Honorable Rod Pacheco.

WHEREAS, The tenure of the Honorable Rod Pacheco with the California State Assembly is drawing to a close following six years of exemplary service, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendations of the people of the state; and

WHEREAS, In 1996 Rod Pacheco was the first Latino Republican elected to the California State Assembly in close to a century, representing the 64th District, he later served as Republican leader for the Republican Caucus, the first time in California's history that a Latino has served as the Republican Leader in the California State Legislature; and

WHEREAS, In his first term in the Legislature, Assembly Member Rod Pacheco served as the Vice Chairman of the Education Committee and the Select Committee on Education Technology, and his efforts in this area have resulted in numerous accomplishments for California's schools, most notably major investments in textbooks and a concerted push for stronger school accountability, increased safety measures on schoolyards, and the implementation of statewide testing standards; and he also brought credit to himself as a member of numerous other committees including Judiciary, Budget, Education, and Public Safety; and

WHEREAS, In 2000 Assembly Member Rod Pacheco worked in a bipartisan way to create the Ortiz-Pacheco-Poohigian-Vasconcellos Cal Grant Act of 2000 and this landmark legislation provides college scholarships to students who have demonstrated academic merit and financial need, which at the time was described by Governor Davis' Education Secretary as "the most significant legislation since the G.I. Bill"; and

WHEREAS, Prior to his election to the California State Assembly, Rod was a Senior Deputy District Attorney for Riverside County where he specialized in homicide and death penalty cases; and

WHEREAS, During Assembly Member Rod Pacheco's first term in office, he authored the successful Proposition 222, The Peace Officer's Safety Initiative, that strengthened the punishment for those convicted of harming a peace officer/firefighter during the commission of a crime, and garnered nearly 80 percent of California voters' support on the June 1998 ballot; and

WHEREAS, Throughout his tenure, he has authored numerous pieces of legislation protecting crime victims, punishing criminals, and providing for the loved ones of slain officers and firefighters; and

WHEREAS, Assembly Member Rod Pacheco's effectiveness and dedication to public safety was acknowledged when he was named

Legislator of the Year by the Riverside Sheriff's Association in 1998, Legislator of the Year by the California Law Enforcement Association Records Supervisors in 1998, Legislator of the Year by Crime Victims United of California in 1999, Legislator of the Year by the California Department of Forestry Firefighters in 2002; he was recognized by both the California Correctional Peace Officers Association and the National Association of Citizens on Patrol, and was named an associate member of the California Fire Chiefs Association; and

WHEREAS, In 1997 the California School Boards Association and the University of California Alumni Association recognized his commitment to education at all levels by naming Assembly Member Rod Pacheco their Legislator of the Year, and he went on to receive the same honor from the Inland Empire Hispanic Image Awards, the California Building Officials/B.T. Collins Memorial Award, the Valley Group, Tri County Republican Leadership Award, the California County Boards of Education, and by Independently Merging Parent Associations in California (IMPAC); and

WHEREAS, His commitment to volunteer public service and to victims of crime has attracted the attention of significant nonprofit organizations; Kidsafe, dedicated to protecting children, and the Doris Tate Crime Victims Bureau, committed to protecting victims of crime, who each named Assembly Member Rod Pacheco to their Board of Directors as an honorary member; and

WHEREAS, In his district, he is a board member of the University of California, Riverside, Friends of Education, and the Fender Museum of Music and the Arts; and

WHEREAS, Assembly Member Rod Pacheco, who has been a resident of the Inland Empire nearly his entire life, earned his Bachelor of Arts degree in 1980 at the University of California, Riverside, and in 1983 he earned his Juris Doctorate degree at the University of San Diego Law School; and

WHEREAS, He resides in Riverside with his wife, Rebecca, and their four children, Miranda, Isabella, Lute, and "Deuce"; and

WHEREAS, Through his public service activities he has made a significant impact on the people of the 64th Assembly District and throughout the state, and he will be greatly missed by those individuals with whom he has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That the Members express their commendations and appreciation to their colleague, the Honorable Rod Pacheco, for his outstanding record of dedicated service to his constituents and to all of the people of California, and convey to him best wishes for every success in his future endeavors.

WHEREAS, He was a member of the National Conference of State Legislators Committee on Criminal Justice and Treasurer of the Legislative Black Caucus of the California State Legislature; and

WHEREAS, Assembly Member Carl Washington's name will forever be associated with school safety and violence prevention and, to a greater extent, the peaceful resolution of conflict, the full protection of

society against crime, the expansion of economic development in the State of California, and the true rehabilitation and redemption of humanity; and

WHEREAS, All of his life's experiences—from minister to youth diplomat, to counselor and community advocate, to mediator and politician, to preacher and peacemaker, and to Assembly Member representing the 52nd Assembly District, culminated in a series of legislative and leadership victories, the least not being the passage of the 1999 Carl Washington School Safety and Violence Prevention Act which provides \$101 million to hire more counselors, to teach conflict resolution, and to enhance school safety infrastructure in grades 8–12 statewide; and

WHEREAS, In the spirit of prevention and redemption, Assembly Member Washington authored Assembly Bill 52, a measure that charted the first course of recovery for a school district in academic and fiscal receivership; and

WHEREAS, With adept balance, he authored both Assembly Bill 743 requiring prisoners to earn their G.E.D. as a condition of their parole, and Assembly Bill 1614, which established a multi-agency law enforcement task force to apprehend criminals and protect drug endangered children; and

WHEREAS, After a five-year fight to establish an enterprise zone in the City of Compton, Assembly Member Washington expanded his vision and with the passage of Assembly Bill 46, created three new enterprise zones in the State of California and effectively brought the hope of economic growth to the entire state; and

WHEREAS, Assembly Member Washington was assisted in his sojourn by the hard work of his District and Capitol staffs, and the loving support of his mother and father, Mr. and Mrs. O.B. and Rosia Washington, his family, and his many friends and supporters; and

WHEREAS, Through his public service activities he has made a significant impact on the people of the 52nd Assembly District and throughout the state, and he will be greatly missed by those individuals with whom he has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That the Members express their commendations and appreciation to their colleague, the Honorable Carl Washington, for his outstanding record of dedicated service to his constituents and to all of the people of California, and convey to him best wishes for every success in his future endeavors.
