Members of the Assembly: As requested by the Joint Legislative Audit Committee (committee), the California State Auditor presents this audit report concerning the rates charged by four water utilities in the Antelope Valley (valley). Specifically, we were asked to audit the rates that three government-owned utilities (public utilities)— Los Angeles County Waterworks, District 40 (LA District 40), Palmdale Water District, Quartz Hill Water District (Quartz Hill)—and one investor-owned utility (investor utility), California Water Service Company (Cal Water) charge their respective customers. In addition, the committee requested that we identify and evaluate significant factors contributing to each water utility's rates.

This report concludes that water rates differ considerably among the four water utilities and that various cost factors affect the water rates that each of them charges. For example, investor utilities incur costs that public utilities do not, including property and franchise taxes. In addition, each utility has access to different revenue sources, with public utilities receiving revenues in addition to monthly water rates, primarily property taxes, which help them cover their costs and contribute to lower rates. A utility's sources of water also contribute to cost variations.

Our review also found that all four utilities increased their water rates between 2011 and 2013 and the utilities were generally able to substantiate reasons for their increases. Furthermore, processes are in place to protect consumers from unreasonable rate increases, which each water utility could demonstrate it followed, with some exceptions for Quartz Hill and LA District 40. However, the requirements for notice under Proposition 218 could be clarified by the Legislature to provide further guidance to public utilities. In addition, a constitutional provision under that same law allowing parcel owners to protest a rate increase is unlikely to prohibit increased rates because it requires that a majority of parcel owners submit a written request.

Finally, the utilities attested to a variety of cost saving efforts to keep their water rates reasonable, but were not always able to demonstrate that these efforts generated any quantifiable cost savings to their customers. Additionally, Cal Water offers two rate assistance programs to qualified customers in the valley while the three other utilities do not currently offer rate assistance programs or discounts to their customers' monthly water bills.

A PROCLAMATION

In July 1982 Tony Gwynn began his Major League Baseball career with the San Diego Padres. He played his entire career with the team, once stating, "One of the things I'm proudest about is that I played for one team. My baseball card looks awesome because it has San Diego all the way down. I grew up in an environment where that kind of stuff was important."

In his 20 years with the Padres, Tony Gwynn had 3,141 hits and a .338 batting average. He represented the Padres in the All-Star Game 15 times and was inducted into the National Baseball Hall of Fame in 2007.

Over the course of his career Tony Gwynn earned the affectionate nickname "Mr. Padre." The Padres retired his jersey, No. 19, in 2004.

After retiring from baseball, Tony Gwynn became head baseball coach for his alma mater, San Diego State University, where he shared his love of the game with a new generation. "I love being on the field, coaching kids and bus rides," he said. "I am made to be a college coach. And it's all right here in my hometown."

In addition to his formidable skills on the field, Tony Gwynn was also admired for his kindness and graciousness and for his exuberant personality.

Tony Gwynn and his wife Alicia established the Tony Gwynn Foundation, which helps fund many organizations supporting children. Tony Gwynn was also active in the Padres Scholars program, which provides college scholarships to middle school students who go on to graduate high school.

On June 16, 2014 Tony Gwynn passed away at the too-young age of 54. On June 26, 2014, more than 23,000 fans attended a memorial for Tony Gwynn at Petco Park.

Today, when the sights and sounds of the game he loved still fill the summer air, I ask all Californians to join in honoring the memory of someone whose talent, sportsmanship and humanity represent the very best of our state. As one sports journalist recently wrote, the late, great and thoroughly decent Tony Gwynn will never stop being honored and that's exactly how it should be.

NOW THEREFORE I, TONI G. ATKINS, Acting Governor of the State of California, do hereby proclaim July 30, 2014, as "Tony Gwynn Day."
