RE: Tentative Agreement/Memorandum of Understanding (MOU) for the California Association of Psychiatric Technicians, Bargaining Unit (BU) 18

Dear Senators Atkins and Wilk, and Assembly Members Rendon and Gallagher: Recently, the California Department of Human Resources reached a new Tentative Agreement/MOU with the union representing BU 18, the California Association of Psychiatric Technicians (CAPT). Upon approval of the Legislature and the Governor, and ratification by the membership, the BU 18 agreement will be effective through June 30, 2025.

The BU 18 Tentative Agreement/MOU contains several compensation changes including a General Salary Increase (GSI) of 2.5% effective July 1, 2022, for all BU 18 classifications, a Special Salary Adjustment (SSA) at max—an increase in the maximum of the salary range for all BU 18 classifications by 4% effective July 1, 2023, and another 4% effective July 1, 2024. Two new pay differentials have also been established for specified employees addressing recruitment and retention and to recognize years of state service. Additionally, a one-time health care facility retention payment and a mental health and wellness stipend have been established as well.

The agreement also includes other benefit changes, language rolled over from previous agreements and changes in the Prefunding of Other Post-Retirement Benefits (OPEB), specifically providing that the employer and employee contribution percentages can increase *or* decrease.

In accordance with Government Code sections 3517.5, 19829.5, and Senate Rule 29.4, I am forwarding copies of the Tentative Agreement/ MOU, including legislative and fiscal summaries. The Legislative Analyst will be forwarded copies for analysis, and the Secretary of the Senate and the Assistant Clerk of the Assembly will be forwarded copies to note them as available for review in the Daily Journals.

Members of the Assembly: My office's investigations division identified a fraudulent payroll scheme at the Department of General Services (DGS) that caused the State to pay \$185,000 in unearned pay and benefits. We found that for nearly four years, a supervisor conspired with a subordinate custodian and falsified timesheets and training records to make it appear that the custodian was performing full-time work for the State even though he did not report to work. In return, the custodian shared a portion of his unearned pay with the supervisor. A building manager's supervisory neglect enabled the fraud and led to additional time abuses that we estimate resulted in payments of unearned wages ranging from \$52,200 to \$98,750.

The complaints that my office investigates are submitted to us in accordance with the California Whistleblower Protection Act, through

which the Legislature encourages state employees to report waste, fraud, abuse of authority, or violation of law without fear of retribution and declares that public servants best serve the citizenry when they can act with candor and honesty. The Act also authorizes my office to issue public reports about substantiated allegations when the State Auditor determines that it serves the interests of the State.

When we notify a state agency or authority of a substantiated allegation, the entity must report to my office within 60 days any corrective or disciplinary action it takes in response to our recommendations, and it continues to report monthly thereafter until it has completed corrective action. In May 2022, DGS provided its response, which we have summarized herein.

Members of the Assembly: Our audit of the State Water Resources Control Board (State Water Board) focused on the board's efforts to help provide Californians with safe drinking water. Nearly a million Californians face possible long-term, negative health outcomes—including an increased risk of liver and kidney problems, as well as cancer—because they receive unsafe drinking water from a failing water system. The State Water Board reported that more than 370 such systems, providing water to more than 920,000 people, were not meeting water quality standards as of December 2021. More than two-thirds of these systems are located in disadvantaged communities with significant financial need.

The State Water Board has funding available to help these failing systems improve the quality of their drinking water. Nonetheless, the board has generally demonstrated a lack of urgency in providing this critical assistance. In fact, the time necessary for water systems to complete applications for funding and for the State Water Board to approve and award that funding nearly doubled from 17 months in 2017 to 33 months in 2021.

The State Water Board's lack of goals and metrics for its application process has likely contributed to this lengthening time frame and has inhibited the board's ability to identify aspects of its review process that it could improve. The longer the board takes to fund projects, the more expensive those projects become. More importantly, delays increase the likelihood of negative health outcomes for Californians served by the failing water systems.

Because failing water systems often lack the expertise to plan and implement water improvement projects, the State Water Board provides them access to contracted technical assistance providers. However, it has yet to implement metrics to gauge the overall performance of these providers and to ensure that the water systems receive timely assistance. Further, the board needs to develop a plan to ensure that its staff and its contracted providers do not duplicate their outreach efforts, thus wasting limited resources.

This bill seeks, until July 1, 2024, to allow the Commission on Teacher Credentialing to waive the basic skills proficiency requirement for purposes of issuing an Emergency 30-Day Substitute Teaching Permit. I welcome another policy vehicle for this proposal that avoids this technical issue.
