**PRAYER**

Upon invitation of Speaker pro Tempore Mullin, the following prayer was offered by Assembly Chaplain Rev. Bob Oshita:

Please join me in a moment of reflection.

Although the world has advanced technologically more in the last seven decades than in the last seven centuries, as a species, we human beings have yet to learn how to live together in peace. In reflecting on the atomic bombing of Hiroshima 73 years ago today, we remember again that we must learn to live together in peace—for humankind can now easily destroy life on earth as we know it.

I remember my first visit to Hiroshima and the Peace Memorial in 1973. My Auntie Toyoko, who lived through the bombing asked me, “How was it?” I said, “It was unbelievable.”

She smiled and said, “What you saw today is nothing.” She explained, “In 1945, this part of Hiroshima was just countryside with rice fields extending up the hillsides. On that morning, we heard a large explosion and we all rushed outside to see what had happened.”

She said, “We were amazed to see such a beautiful cloud billowing over Hiroshima. We wondered, ‘What could have created such a beautiful cloud?’ Then we noticed a small fire had started on our roof. But we had to laugh because it was so strange. Not just our roof, but every roof of the few homes that dotted the hillside was on fire in exactly the same way. We wondered, ‘How can this be?’ We admired the cloud and laughed in disbelief at the uncanny fires. We were so innocent. It was like a strange dream. Only later did we learn that a nightmare had happened.”

She went into detail telling me about the “walking dead” that fled Hiroshima, badly burned, walking in shock with vacant eyes, asking for water. And she said, “When we tried to give them water, they just kept walking by, not seeing us at all.” Then she said again, “What you saw today was nothing.”

But it was enough for me. And it should be enough for all humanity.

Reflecting on the atomic bombing of Hiroshima and Nagasaki 73 years ago, let us rededicate ourselves to keep the dream of world peace alive within us. World peace begins with each of us. World peace begins with my patience and kindness and peace of mind. Healing the wounds of hate begins with me. Hope for a better world begins with me.
