Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the Department of Veterans Affairs' Farm and Home Purchase Program (Cal-Vet program).

This report concludes that the Cal-Vet program will substantially lose its ability to offer low-cost home loans to veterans beyond the next decade due to the restrictive eligibility requirements attached to one source of program funding and limited availability of its two other funding sources. In addition, the Department of Veterans Affairs is eroding Cal-Vet program funds by charging the program for unrelated administrative costs and by operating the program less efficiently than it could.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the effectiveness of the procedures that the California Department of Transportation (Caltrans) permitting unit uses to approve travel routes for oversize vehicles and loads.

This report concludes that Caltrans has identified the major problems with its permitting process: poor communication of roadway information and an inefficient manual system for writing permits. Moreover, the corrective actions Caltrans is pursuing, such as drafting new policies, hiring additional staff, and developing a proposal and seeking approval for an automated routing system, are generally appropriate. However, we suggest that further improvements are needed, such as designating district staff to coordinate communication between the permits branch and field personnel and ensuring that its policies are clearly communicated to those who have responsibility for implementing them.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning our review of the Grant Joint Union High School District (Grant).

This report concludes that Grant could improve its administrative practices in several areas. For example, Grant did not obtain the board of trustees' advance approval for certain contracts although state law and board policy require it to do so. It also does not have sufficient controls over contracts initiated by its legal counsel. Further, Grant lacks an adequate system to track and safeguard its current inventory totaling more than \$32 million. Finally, it has not taken the necessary steps to consistently measure whether its Title I, Part A, of the Elementary and Secondary Education Act program is effective.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning our review of the Kern County Economic Opportunity Corporation (KCEOC).

This report concludes that the controversy over compensatory time off (CTO) practices and policies resulted from poor communication between the KCEOC board of directors (board) and some members of management. Although both parties are at fault, management is particularly to blame because it missed numerous opportunities to inform the board about the CTO. In addition, we observed certain weaknesses in internal controls including mismanagement of health center billings, questionable costs charged to grants, poor inventory practices, inappropriate loans between grants, and other less serious, but troubling weaknesses. The board has also suffered from vacancies and absences, and has violated open meeting laws and its bylaws. These problems and weaknesses hinder KCEOC's mission of providing services to the low-income, disadvantaged, and elderly residents of Kern County.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning statewide efforts to acquire and manage land for ecosystem restoration and wildlife habitat preservation, both within and independent of the CALFED Bay-Delta Program (Calfed).

This report concludes that although Calfed does not acquire land for these purposes, it funds projects that may include land acquisition that support its goals for restoring the ecosystem. Also, the State does not have a comprehensive land use policy to guide state entities in their efforts to preserve and restore the environment. Consequently, although



there is some degree of coordination among these entities, no central vision exists of how their efforts benefit the State as a whole. California also needs to track data such as the purpose for which land was acquired to facilitate its land use planning. In addition, the Department of Fish and Game and the Department of Parks and Recreation—the major acquirers of state land for environmental purposes—need to improve their management of this land.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the compensation of part-time teaching faculty within the California Community Colleges system.

This report concludes that community college districts pay their part-time faculty significantly less for the same teaching duties than full-time faculty. However, perspectives vary on whether this pay inequity creates a fiscal incentive for using part-time faculty that may eventually harm the long-term quality of education or whether the pay inequity represents an appropriate balance of market conditions that should not be tampered with. We present some possible options should the Legislature choose to take action to eliminate existing pay differences between part-time and full-time teaching faculty within the California Community Colleges system.

*To Members of the California Assembly:*

I am returning Assembly Bill No. 1796 without my signature.

Serving as a grand juror is a privilege which is honored in our society. People apply to serve as a grand juror and submit to an interview process. This legislation would seek to increase grand juror compensation from \$10 per day to \$25 per day.

I recently signed legislation increasing trial court juror pay from \$6 per day to \$15 per day. I do not believe that jurors who are summoned, and thus, commanded to serve should be paid less compensation than a grand juror, and therefore, I must veto this bill.

**Veto Message—Assembly Bill No. 1841**

*To the Members of the Assembly:*

I am returning Assembly Bill 1841 without my signature.

Existing law authorizes Caltrans to permit extra-size vehicles. Operators must apply for a permit and identify the size of the load to be transported and the proposed route to be traveled. Caltrans permit staff review the dimensions of the load and ensure the route is clear (e.g., that bridge clearances are adequate) for safe travel. If the route is clear, Caltrans issues a permit. The operator must have the permit in his possession during the trip.

This bill would broaden an existing exemption from permit requirements for the operation or movement of implements of husbandry on the highways. Existing law allows farmers or regular employees of farmers to haul over-height implements of husbandry up to 25 miles from the point of origin without an over-size truck permit issued by Caltrans.

This bill would strike the requirement that the farmer's employee be a regular employee. As a result, this bill could apply to anyone

employed by a farmer or farming corporation—for example, a short term employee who is not adequately trained to operate over-size or over-height equipment.

This measure is opposed by both the Department of Transportation and the California Highway Patrol; the two agencies charged with protecting public safety on California roads and highways. Public safety remains a paramount concern.

For these reasons, I must veto this bill.

**Governor's Message—Assembly Bill No. 2788**

*To the Members of the Assembly:*

I am returning Assembly Bill 2788 without my signature.

This bill makes several changes to the Gambling Control Act, including increasing penalties for bookmaking, and authorizes the Attorney General to bring an action pursuant to the Red Light Abatement Act. There are some good features to this measure, and I would sign legislation focused exclusively on enhanced penalties and additional enforcement authority of the Attorney General.

However, the measure contains several provisions for which I have concerns. I am particularly concerned that the bill would eliminate the requirement that voters approve any substantial expansion of card room gaming. (Existing law permits a modest expansion of up to 25%; anything more requires voter approval.) Moreover, the bill appears to authorize percentage gaming, which is otherwise prohibited by Penal Code Section 330. To the extent that the bill authorizes percentage gaming, it may well violate Article IV, Section 19(e) of the California Constitution.

For these reasons, I cannot sign this measure.

**Veto Message—Assembly Bill No. 1929**

*To the Members of the Assembly:*

I am returning Assembly Bill 1929 without my signature.

This bill would require the State Department of Education to study the feasibility of consolidating the application process for school districts or county superintendents seeking to operate multiple similar programs, and, where possible, to group similar programs and develop a single application for each group of programs. There are currently 15 programs that are participating in the existing consolidated application process at the State Department of Education.

I endorse the streamlining of programs and program-applications, but I question the need for the feasibility study required by this bill. First, for programs to be included in the consolidated application, the program staff need only request to have the program included. Second, the application for, and state administration of, several major statewide categorical programs have already been consolidated. Programs that do not lend themselves to inclusion in the consolidated application because of their specific requirements or their lack of relevance to school districts statewide have been, and should remain, excluded from the consolidated application process.

I would be pleased to work with the author to determine if there are further programs that should be added to the consolidated application process, and request that the State Department of Education include them as part of its administrative functions.

**Veto Message—Assembly Bill No. 2108**

*To the Members of the California Assembly:*

I am returning Assembly Bill No. 2108 without my signature.

This legislation would require the Department of Corrections to ensure that the standard of hospice care for female inmates at the Central California Women's Facility be equivalent to the level of care provided to male inmate hospice patients at the California Medical Facility. The bill would also expand the eligibility criteria for placement of female inmates in the Family Foundations Program. Additionally, the bill would state legislative intent to encourage the University of California and the Department of Corrections to establish a medical residency program at the California Medical Facility.

This bill is unnecessary because as of July 1, 2000, the California Department of Corrections began operating a hospice facility for the



critically and terminally ill women in prison. This program, as the author correctly intends, will be equivalent to the services provided for the male prison inmates at the California Medical Facility.

I favor additional drug treatment options in prison and for parolees and to date we have added more than 6000 in-prison drug treatment beds and increased drug treatment programs for parolees. I object, however to the provisions of the bill that would eliminate prison sentences for serious drug offenses that include trafficking, sale or manufacturing.

#### **Item Veto—Assembly Bill No. 2885**

*To the Members of the Assembly:*

I am signing Assembly Bill No. 2885; however, I am deleting the allocation and the funding for the juvenile justice programs contained in this measure.

This bill appropriates \$242,600,000 General Fund to provide funding for continuation of the Citizens' Option for Public Safety (COPS) program and to establish and fund local juvenile justice programs. From this \$242,600,000 appropriation, the bill allocates (1) \$121,300,000 for the COPS program (5.15 percent, \$12,500,000 to district attorneys; 5.15 percent, \$12,500,000 to counties for jail operations; and 39.7 percent, \$96,300,000 to local agencies for front-line law enforcement), and (2) \$121,300,000 to counties for juvenile justice programs. The provisions of this bill would sunset on January 1, 2005, and states legislative intent to appropriate at least \$242,600,000 in fiscal years 2001–02, 2002–03, and 2003–04 for the purposes of funding the provisions of this measure.

The COPS program has provided supplemental funding to counties, cities, and special police protection districts for local law enforcement services in order to enhance public safety. This bill would provide statutory authority to continue this worthy program through 2003–04. I support continuing the COPS program and providing the full funding at the \$121,300,000 level allocated under the provisions of this measure.

With respect to the juvenile justice provisions in the bill, while I am supportive of programs that reduce juvenile crime and delinquency, the programmatic justification for the juvenile justice programs in the bill is insufficient to support the General Fund appropriation for this purpose.

In addition, given the lack of information regarding the components of the juvenile justice programs, the benefits of these programs as currently configured are unclear. Therefore, I am deleting the \$121,300,000 intended to fund the juvenile justice programs.

I would be supportive of subsequent legislation that would appropriate \$71,300,000 General Fund for proven juvenile justice programs and which contains the following components: (1) provisions specifying the funding in the measure would not be for the purpose of supplanting existing local funding, (2) provisions delineating a mechanism for the programs being funded to be measured and assessed for both expenditures and success, and (3) provisions specifying the criteria and standards for the use of the funds. Additionally, this subsequent bill should also include a \$9,210,000 General Fund appropriation for the Turning Point Academy program that was inadvertently left out of the Budget Bill.

In Section 2, paragraph (b)(4) of the bill, I am deleting the following:

~~(4) Fifty percent to the county or city and county to develop and implement a comprehensive multiagency plan that provides for a continuum of responses to juvenile crime and delinquency and demonstrates a collaborative and integrated approach for implementing a system of swift, certain, and graduated responses for at-risk youth and juvenile offenders. This plan shall be developed by the local juvenile justice coordinating council in each county and city and county pursuant to Section 749.22 of the Welfare and Institutions Code and approved by the county board of supervisors, and in the case of a city and county, the plan shall also be approved by the mayor.~~

~~(A) The SLESF shall only allocate funding pursuant to this paragraph upon the submission by the local juvenile justice coordinating council of a local action plan to the county board of supervisors and the Board of Corrections.~~

~~(B) The local action plan shall identify ways for improving and marshaling existing resources to reduce the incidence of juvenile crime and delinquency in priority areas and the greater community. The plan shall also maximize the provision of collaborative and integrated services and shall specify strategies for all elements of response, including, but not limited to, prevention, intervention, suppression, and incapacitation to provide a continuum for addressing the identified juvenile crime problem. The plan shall also identify strategies for addressing gang and gender specific issues. The plan shall also identify outcome measures to help determine the effectiveness of the program which shall include, but not be limited to, the following:~~

~~(1) The rate of juvenile arrests per 100,000 of population.~~

~~(2) The rate of successful completion of probation.~~

~~(3) The rate of successful completion of restitution and court-ordered community service responsibilities.~~

In Section 3, paragraph (a) of the bill, I am deleting the following:

**Item Veto—Assembly Bill No. 2928**

Governor's Office, Sacramento

July 6, 2000

*To Members of the Assembly:*

I am signing Assembly Bill No. 2928, a comprehensive transportation funding measure which incorporates most of the proposals I made for almost \$5 billion in congestion relief, transportation system connectivity and goods movement projects. The bill also provides over \$1.4 billion in additional funds over five years for local street and road maintenance, transit operations and State Transportation Improvement Program projects.

However, I am reducing or eliminating certain appropriations made in Section 6 of the bill, which adds Chapter 4.5 (commencing with Article 5, Section 14556.40) to Part 5.3 of Division 3 of Title 2 of the Government Code, by a total of \$93,800,000. These expenditures are being eliminated because I have specific concerns about the projects and their priority for inclusion in this plan, and about the precedent these projects would set with respect to state expenditures. Additionally, I am requesting that the Legislature enact subsequent legislation to correct certain technical defects in this bill and modify the financing of the program to have less of an impact on the State General Fund in future years.

I am reducing the expenditures in Chapter 4.5, Article 5, Section 14556.40, Subsection (a) of the Government Code by eliminating or reducing the following paragraphs:

Paragraph (120) is eliminated, which allocates \$1,500,000 to Yuba County for the Yuba Airport runway extension and associated improvements. This project is not a congestion relief project affecting most travelers in the area.

Paragraph (125) is eliminated, which allocates \$5,000,000 to the Orange County Transportation Authority for the Route 57 toll road environmental impact report and study for expansion project. The franchise agreement for this project prohibits use of state funds in this fashion.

Paragraph (130) is eliminated, which allocates \$3,500,000 to the City of Garden Grove for the Route 22; connector to the interchange with I-405. Over \$206 million for Route 22 is already included in paragraph (70).

Paragraph (131) is eliminated, which allocates \$800,000 to the town of Apple Valley for the Bear Valley Road closure project and Kasota Road safety redesign. Funding for this project may be available in the State Highway Operations and Preservation Program and through local street and road funding.

Paragraph (132) is eliminated, which allocates \$7,000,000 to Los Angeles County for the Fairway Drive grade separation project in the San Gabriel Valley. This project already has access to several funding sources through the Alameda Corridor East Project.

Paragraph (136) is eliminated, which allocates \$3,500,000 to City of Palmdale for the widening of Avenue S; between Route 14 and Route 138. This project does not appear to provide significant congestion relief or to fit other priorities for use of these funds.

Paragraph (137) is eliminated, which allocates \$5,500,000 to City of Lancaster for improvements to the Fox Field Industrial Corridor. This project does not appear to provide significant congestion relief or to fit other priorities for use of these funds.

Paragraph (138) is reduced by \$3,000,000 to \$4,000,000, which allocates funds to the Cross Valley Rail Corridor Joint Powers Authority for the upgrade of railroad track from Visalia to Huron. This project mainly funds improvements to rail lines that will be used by short line freight rail. Although I recognize that this project may provide significant local goods movement capacity, I expect local and railroad funds to provide the majority of funding.

Paragraph (142) is reduced by \$1,500,000 to \$2,000,000 for the City of West Hollywood for the repair, maintenance, and mitigation of Santa Monica Boulevard. A portion of this project appears to be eligible for the street and road maintenance funding provided in this measure.

Paragraph (143) is eliminated, which allocates \$1,900,000 to the Capital Corridor Joint Powers Authority for the expansion of intercity rail service between San Jose, Oakland, and the Sacramento region. Such service cannot be implemented this year, and the ongoing operating costs should be funded from the Public Transportation Account in due course.

Paragraph (144) is reduced by \$45,000,000 to \$5,000,000 for the Golden Gate Bridge Highway and Transportation District for the seismic retrofit of the Golden Gate Bridge. It is my understanding that other funding sources are available, and Caltrans will be working with the District to assist in securing federal funding for this project.

Paragraph (147) is eliminated, which allocates \$7,000,000 to the Imperial Valley Association of Governments for the reconstruction of the I-8/Imperial Avenue interchange. This project does not appear to provide significant congestion relief or to fit other priorities for use of these funds.

Paragraph (155) is eliminated, which allocates \$8,600,000 to the City of Chula Vista to acquire right-of-way, build, and operate a 10-mile limited access toll facility from San Miguel Road to Otay Mesa Road and conduct a due diligence review, including an independent appraisal of the feasibility of acquisition by a public agency of the Route 125 franchise agreement authorized under Section 143 of the Streets and Highways Code. I do not support state funding for the acquisition of a private toll road franchise.

Additionally, I am taking identical actions on the same projects as listed in SB 406, a measure that corrects certain provisions of this bill.

This level should be sufficient to allow the Department to continue its currently budgeted operations for several years, while providing some moderate room for growth in program costs.

**Governor's Message—Assembly Bill No. 2876**

*To Members of the Assembly:*

I am signing Assembly Bill No. 2876, which makes statutory changes in the area of human services that are necessary to implement the Budget Act of 2000.

However, this bill also includes legislative intent that limited-term housing assistance be funded out of the employment services budget of the CalWORKs program, where appropriate. I am opposed to this provision because the CalWORKS grant is designed in part to defray housing costs and because limited-term supplemental assistance is provided through the Homeless Assistance Payment program or through other special needs payments. I am also opposed to this provision because of the potentially major cost pressures that would crowd out funds for the employment services portion of the program.

Therefore, I am directing the Department of Social Services to reject as inappropriate those county claims for limited term housing assistance that are not tied to specific parts of the existing CalWORKs program

and to target the allocation of employment services funding on a priority basis for existing CalWORKs purposes.

**Governor's Message—Assembly Bill No. 2866**

Governor's Office, Sacramento

*To Members of the Assembly:*

I am signing Assembly Bill No. 2866; however, I am concerned about several provisions contained in this measure.

First, I am deleting Section 10 of this measure, because it contains an appropriation. This section would authorize the Board of Control to enter into an interagency agreement with the University of California, San Francisco, to establish a victims of crime recovery center, as a pilot project until June 30, 2004, at San Francisco General Hospital; and to establish supplemental mental health rates for eligible victims. By providing for new and expanded uses of a continuously appropriated fund, Section 10 of this bill would make an appropriation.

Consistent with my strong support for victims' rights, I sustained a total of \$525,000 in the 2000 Budget Act for one-time start-up costs for the victims of crime recovery center. However, I am concerned Section 10 would fund services that are normally not reimbursed and at rates that are twice the current level. The enhanced mental health reimbursement rates, funded by the Restitution Fund which is continuously appropriated to the Board of Control, could set a potentially costly precedent that could ultimately have a negative impact on the Restitution Fund and the ability to fund services to victims on a statewide basis.

I am also deleting Section 36 to conform with this action.

Second, I am concerned about provisions included in this measure that would require an assessment of rail transportation in California and recommendations for projects. While I do not object to assessing the potential for greater connectivity of the passenger rail system with other passenger travel modes, improved public safety, and mitigating congestion on rail corridors providing passenger service, I am concerned with the bill's implication that the State should propose projects to support private freight rail capital needs.

While I recognize that movement of goods has a strong tie to the state's ability to support commerce, I also recognize that private, for-profit companies that operate freight railroads are substantially capable of funding their own capital and operating needs. I am directing the Department of Transportation to limit its rail recommendations to those which are the proper subject of state funding, prioritizing them in context of the state's other pressing transportation needs. Furthermore, I would support legislation directing the University of California to conduct the private rail assessment.

In contrast to the sweeping request for project recommendations in this bill, the Traffic Congestion Relief Plan I proposed contains funding for priority freight rail-related capital projects which will relieve congestion on highways and streets. Funds proposed for the publicly-owned North Coast Rail Authority will restore service thereby reducing the burden on Route 101. Funds proposed for an eastern

extension of the Alameda Corridor project are based on the expectation that the freight rail company that participates in the Alameda Corridor project will contribute substantial funding, commensurate with the benefits it will obtain, while government funding is used substantially to reduce the conflicts between rail operations and street and highway traffic.

I am signing AB 1544, which will resolve a 10-year-old dispute and facilitate the development of the unincorporated area surrounded by the City of Redlands known as the "doughnut hole".

Last year I vetoed a nearly identical measure, AB 1553, and encouraged local officials and affected property owners to resolve this issue quickly. Unfortunately, resolution has not been reached. While I generally do not favor state intervention into local land use decisions, this is a unique situation where state action is warranted. This measure is necessary to facilitate the transition of the former Norton Air Force Base from military to civilian use, as was envisioned with the creation of the Inland Valley Development Authority. Moving forward with the development of this property is critically important to job creation in the Inland Empire, particularly in light of the 10,000 jobs lost due to the base closure.

This bill passed with the overwhelming endorsement of the State Legislature, more than a 2/3 vote in each house, many of whom are former local elected officials and strong advocates of local control. By signing this bill, I am not in any way preventing local government from amicably and fairly resolving this longstanding controversy with the property owners. In fact, I strongly urge the parties to once again attempt in good faith to reach an accord.

I am signing Assembly Bill 2872, the omnibus environmental protection trailer bill, which implements several important policy initiatives contained in the Budget Act of 2000. Those initiatives include the establishment of a biomass facility grant program, developing cancer and school site risk assessment guidelines, monitoring air quality in portable classrooms, and cleaning up contaminated properties in urban areas ("brownfields").

However, in addition to programs funded in the Budget, this bill also contains programs for which funding is not provided. One is for the development of a geographical information management system for the Certified Unified Program Agencies (CUPA program). While there may be value in the collection of data from regulated businesses under the program, funding for such a system should be considered through the normal budget process.

In addition, the need for a *new* study of white croaker fish boundaries off the Palos Verdes Shelf is questionable. The State already has conducted a white croaker fish study, established fish closure boundaries, and received \$3,100,000 in federal funds to enforce the existing fish closure; therefore, there is no need for another study.

Notwithstanding these concerns, I am signing this measure.

I am signing Assembly Bill 1918.

This bill would require community colleges to distribute a copy of the current transfer core curriculum to each student, and encourage copies of the curriculum to be made available at various campus locations.

I am supportive of increasing the numbers of community college students who go on to four-year colleges and universities, as



demonstrated by the \$155 million augmentation to Partnership for Excellence program in the 2000 budget. In addition, the California Community Colleges have also signed Memoranda of Understanding with the University of California and California State University that would provide for annual increases in transfers of 6 percent and 5 percent, respectively.

To further the objective of community college transfers to 4-year institutions, I would expect all Community College Districts to make information on core curriculum transfer requirements available to every student as a matter of practice. The logical and most cost-effective method would be to include this information in the class schedule.

I am signing Assembly Bill No. 2252 because it both promotes and supports an aeronautic future when Reusable Launch Vehicle flights will likely become common in California. However, I do believe that important safety, environmental and community concerns need to be addressed prior to the designation and certification of each site. While it is likely that some existing airports can and will safely meet local, state, and federal requirements, certification and administrative procedures need to be clarified.
