Veto Message—Assembly Bill No. 2423

Governor's Office, Sacramento
July 24, 2006

To the Members of the California State Assembly:

I am returning Assembly Bill 2423 without my signature.

Although meritorious in its intent to provide targeted science instruction in the elementary schools, this bill is unnecessary. Nothing in current law precludes school districts from designating a teacher as a science coach, or from providing staff development in science instruction at the local level.

Furthermore, this bill prohibits a district from using funds other than staff development funds for these purposes. This provision would restrict districts' budgetary flexibility and prevent them from using other fund sources to support designated science coaches or provide this type of targeted professional development. It appears that this provision actually runs counter to the bill's purported intent.

For these reasons, I am unable to sign this bill.

Item Veto Message—Assembly Bill No. 1802

Governor's Office, Sacramento
July 19, 2006

To the Members of the California State Assembly:

I am signing Assembly Bill 1802 with the following objections:

I am reducing one-time appropriations contained in subdivision (a) of Section 43 of the bill for community colleges:

I am reducing the appropriation in subdivision (a) of Section 43 of this bill by eliminating schedule (28), which allocates \$500,000 for implementation of a community college strategic plan. Funding for the implementation of community colleges' strategic plan is not an appropriate use of Proposition 98 funds and can be funded by the Chancellor's Office to the extent this is a priority for that organization.

I am reducing the appropriation in subdivision (a) of Section 43 of this bill by eliminating schedule (29), which allocates \$700,000 to support an Electronic Transcript Exchange program. This additional

funding is unnecessary, given that the Budget Bill already provides federal reimbursement authority for this purpose.

I am reducing the appropriation in subdivision (a) of Section 43 of this bill by eliminating schedule (31), which allocates \$5,000,000 to support faculty and staff professional development. This funding is unnecessary due to the significant increases in general purpose funding and one-time funds that are available for this and other purposes. Decisions to provide additional funding for these programs should be made at the local level.

As mentioned in my veto message on Item 6870-101-0001 in AB 1801, I am committed to increasing the amount of funding for career technical education given the magnitude of work remaining to be done to reinvigorate and align career technical in our high schools and community colleges. Therefore, I am setting these funds aside for appropriation in subsequent legislation for this purpose.

Also, Section 12 requires the State Department of Education to reimburse school districts \$0.21 for every free and reduced-priced meal served to California students. Currently, the reimbursement rate is \$0.14 for free and reduced price meals. However, I have deleted and set aside \$37.8 million included in the Budget Bill for this rate increase pending the adoption of legislation that would require schools to improve the nutritional quality of meals served to California students and restore the \$37.8 million appropriation.

To the Members of the California State Assembly:

I am signing Assembly Bill 1805 because it is critical to the enactment of the state budget.

However, there are still technical issues relating to Sections 2, 3 and 4 of the bill that still must be resolved and may require subsequent legislation. Therefore, I am convening a working group that includes members of my Administration and representatives from local law enforcement and local governments to review and address issues relating to the implementation of local detention facility revenue accounts and any modifications to the current method of collecting fees for the reimbursement of city or county expenses when an arrested person is brought to the jail for booking or detention. The discussion will include, but not be limited to, the roles and responsibilities of local

entities, appropriate overall funding totals, and multi-year contracting issues with the objective of concluding discussions prior to December 1, 2006.

In addition, I am asking the working group to consider and make recommendations regarding the detail, scope and timeline for a study of booking and arrest patterns by California law enforcement agencies by December 15, 2006. In making these recommendations the working group should consider the type and amount of data currently available and necessary to evaluate the policy and fiscal implications of the implementation of Government Code Section 29550, 29551 and 29552 and related issues on all affected public agencies.
