Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the California Department of Transportation (Caltrans) and the Metropolitan Transportation Commission (MTC) to examine the delays and higher cost estimates for the seismic upgrades of toll bridges in the Bay Area.

This report concludes that the seismic retrofit costs of state-owned toll bridges have significantly exceeded Caltrans' original estimates for many reasons; however, the largest contributor is the east span replacement of the San Francisco-Oakland Bay Bridge with an estimated cost increase of \$1.3 billion. Overall, the program was likely to experience such increases because statute allows the Bay Area to purchase a more expensive east span replacement than Caltrans originally envisioned and estimated for. This statute also requires that bridge users fully fund the cost increase with the seismic retrofit surcharge imposed for passage on all Bay Area toll bridges. Caltrans also recognizes that the lack of including escalation rates in most of its estimates played a role in the understatement of estimated costs in the initial legislation. Additionally, external parties delayed project progress and subsequently increased costs. Although Caltrans maintains that its current funding is sufficient to cover estimated program costs, recent information suggests that Caltrans may need additional funding.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the ongoing fiscal problems at the California Department of Corrections (department).

This report concludes that a shortage of correctional officers continues to result in high overtime costs, which exceeded \$110 million

in the first half of fiscal year 2001–02. We estimate it could take the department until the beginning of 2009 to resolve the shortage. In addition, certain provisions of the new labor agreement between the State and the California Correctional Peace Officers Association increase the department's fiscal burden and limit management's control. We estimate that the department's annual costs related primarily to correctional officers for five new and three continuing provisions of the labor agreement will amount to approximately \$518 million by the end of fiscal year 2006–07.

#### Legislative Intent—Assembly Bill No. 2158

RE: AB 2158 (Lowenthal) Affordable Housing: Prospective Nature of Bill

Dear Mr. Speaker: As principal author of AB 2158, I want to address an issue raised and assuage any concerns my colleagues may have.

AB 2158 directs the California Coastal Commission to take all appropriate legal steps to protect approximately 400 affordable housing units under its jurisdiction in Orange County that were created prior to 1981 when the Coastal Act contained affordable housing policies (formerly Section 30213 PRC). These units were created in conjunction with the issuance of coastal development permits for new subdivisions and included permit conditions establishing resale controls in order to protect continued affordability of the units. It appears that many of the subject units may have been rented or released from the program contrary to legal requirements in grant deeds secured and agreed to by the original qualified buyers. These units may soon be lost from the already inadequate pool of affordable housing in the region unless steps are quickly taken to address the violations. AB 2158 makes clear the Legislature expects the Commission to give priority to this program within its existing resources.

A concern has been raised about whether AB 2158 authorizes the Commission to prevent the market rate sale of units that have been continuously occupied by the holder of the grant deed for the requisite period of time and in conformity with the conditions of the attachment to grant deeds. Under such circumstances the Commission cannot lawfully prevent the resale because doing so would abrogate legal contracts. AB 2158 does not and cannot authorize actions contrary to constitutional protections of contract rights. Accordingly, nothing in AB 2158 would allow the Commission to take actions that prevent the resale at market rates of those units whose owners complied with all terms and conditions of the grant deeds and attachments.

I submit this letter to the Journal the same day the full Senate votes on the bill as an expression of Legislative intent with respect to AB 2158.
