RE: Tentative Agreement/Memorandum of Understanding (MOU) for Bargaining Unit 10, California Association of Professional Scientists—International Union, United Automobile, Aerospace and Agricultural Implement Workers of America (CAPS-UAW)

Dear Senators McGuire and Jones; and Assembly Members Rivas and Gallagher: The California Department of Human Resources has reached a new Tentative Agreement/MOU with the union representing Bargaining Unit (BU) 10—CAPS-UAW. Upon approval by the Legislature and the Governor, and ratification by employee membership, the agreement will be effective through July 1, 2027. In accordance with Government Code sections 3517.5, 19829.5, and Senate Rule 29.4, please accept the attached Tentative Agreement/MOU, including legislative and fiscal summaries.

The Tentative Agreement/MOU adjusts compensation by raising minimum and maximum salary ranges. Effective July 1, 2024, employees who are not at the former maximum salary of their classification shall receive a 3 percent Special Salary Adjustment (SSA) and those at the former maximum salary shall receive an SSA of between 6 and 12 percent. The agreement also includes targeted recruitment, retention, and longevity incentives, and transitions employees to the State Disability Insurance program.

Additionally, the Tentative Agreement/MOU establishes Joint Labor Management Committees to consider and discuss the potential consolidation of BU 10 classifications and to review promotional pathways for specified classifications. During the term of the Tentative Agreement/MOU, CalHR will initiate an audit of work performed by BU 10 classifications to ensure that the work performed meets the classification specifications according to the classification plan.

Finally, this agreement carries forward language from previous agreements and makes various other benefit and labor changes. The Tentative Agreement/MOU and summaries can also be found by going to the following link: Labor Relations Unit 10—Professional Scientific.
