Dear Mr. Speaker: I respectfully request this letter be entered into the Assembly Journal to clarify the legislative intent of AB 2352.

AB 2352 will allow Residential Care Facilities for the Chronically Ill (RCFCIs) to expand the types of residents that can be admitted into their facilities to include residents who have terminal illnesses other than HIV or AIDS. The legislative intent of AB 2352 (Jackson) is to give priority to residents that have HIV or AIDS, but to allow a RCFCI to care for other residents with terminal illness if they are not able to fill to capacity with patients with HIV or AIDS.

This letter is intended to provide direction to the Department of Social Services that when it updates its regulations to reflect the changes in AB 2352, that the changes reflect the legislative intent that HIV and AIDS patients shall have first priority for RCFCI bed space.
