# Governor's Message—Assembly Bill No. 500

Governor's Office, Sacramento August 9, 2000

To the Members of the Assembly:

I am signing Assembly Bill No. 500 with the following comments.

I am not in favor of legislative bans that restrict commerce. However, in the East Bay, a ban on trucks in excess of 9,000 pounds on a 10-mile section of I-580 has been in continuous effect since 1963. A study by Caltrans found no reason to lift the ban. To do so would be a breach of good faith with the residents of Oakland.

I also note the permanent ban is supported by City of San Leandro, East Bay Regional Park District, Gan-Trans-Ltd., City of Oakland, Alameda County Fire Department, MV Transportation, Inc., California Teamsters, Alameda County Board of Supervisors, Central Labor Council of Alameda, Bay Cities Metal Council, Alameda County Waste Management, San Leandro Chamber of Commerce, Hill Area Coalition and numerous residents of Oakland.

For these reasons, I am signing this bill.
