MESSAGES FROM THE GOVERNOR

The following veto message from the Governor was received and ordered printed in the Journal and the bill ordered to the unfinished business file.

Veto Message—Assembly Bill No. 1956

Governor's Office, Sacramento August 10, 1998

To the Members of the California Assembly:

I am returning Assembly Bill No. 1956 without my signature.

This bill would establish procedures and provide authority for the California Coastal Commission to file and record notices of violation when it determines that property within the coastal zone has been developed in violation of the California Coastal Act.

This authority is unnecessary. Existing law provides the Commission with numerous procedures to halt violations of the Coastal Act, including provisions which allow for judicial review.

Under existing law, if the Coastal Commission alleges a Coastal Act violation, either party may go to court to settle the dispute. In court, the Commission has the burden of proving the violation. Under this bill, if the Commission files a notice of violation, and the parties proceed to court, the alleged violator would be forced to prove that the Commission is in error. Shifting the burden of proof from a governmental regulatory agency to the property owner is an inappropriate enhancement of governmental powers at the public's expense.

During the negotiations, we asked for a legislative counsel opinion about the constitutionality of this provision.

We received the opinion yesterday. Counsel concluded that the provision would be valid if the amendments serve a statewide purpose. I request that this letter and the attached opinion be published in the *Assembly Journal*.

Taxation: Retroactivity: Employee Stock Ownership Plans—#17732

Dear Mr. Villaraigosa: You have asked whether an amendment to subdivision (a) of Section 18042 of, and subdivision (a) of Section 24611 of, the Revenue and Taxation Code, that would apply those provisions to taxable and income years beginning on or after January 1, 1995, and therefore result in the eligibility of certain taxpayers for a refund of taxes for those taxable and income years, would be valid if enacted.

Subdivision (a) of Section 18042 of the Revenue and Taxation Code ¹ reads as follows:

"(a) Section 1042 of the Internal Revenue Code, relating to sales of stock to employee stock ownership plans or certain cooperatives, applies to taxable years beginning on or after January 1, 1996."

Section 18042 conforms the Personal Income Tax Law (Pt. 10 (commencing with Sec. 17001), Div. 2) to federal tax law by providing that Section 1042 of the Internal Revenue Code, relating to sales of stock to employee stock ownership plans or certain cooperatives, applies to taxable years beginning on or after January 1, 1996. The effect of Section 18042 is to provide that, for taxable years beginning on or after January 1, 1996, certain shareholders, under certain circumstances, may roll over, without recognizing gain, proceeds from the sale of their securities to an employee stock ownership plan. ²

Former Section 18042 (Ch. 1504, Stats. 1988) provided that conformity until January 1, 1995. In 1996, Section 18042 was amended to provide that conformity to taxable years beginning on or after 1996 (Ch. 954, Stats. 1996). However, there was no conformity to Section 1042 of the Internal Revenue Code for the taxable year beginning in the 1995 calendar year.

Subdivision (a) of Section 24611 reads as follows:

"(a) Section 404(k) of the Internal Revenue Code, relating to dividends paid deduction, shall apply to income years beginning on or after January 1, 1996."

Section 24611 conforms the Bank and Corporation Tax Law (Pt. 11 (commencing with Sec. 23001), Div. 2) to Section 404(k) of the Internal Revenue Code, relating to dividends paid deduction, for income years beginning on or after January 1, 1996. This conformity allows a deduction for dividends paid by a corporation on certain employer securities held by an employee stock ownership plan.

All further section references are to the Revenue and Taxation Code, unless otherwise indicated.

² Prior to 1998, the Bank and Corporation Tax Law (Pt. 11 (commencing with Sec. 23001), Div. 2) did not conform to Section 1042 of the Internal Revenue Code. In 1997, Section 24954 was added to provide that conformity to the federal tax law for income years beginning on or after January 1, 1996 (Chs. 604 and 611, Stats. 1997).

Former Section 24611 (Ch. 698, Stats. 1992) also provided that conformity until January 1, 1995. In 1996, Section 24611 was amended to provide that conformity to taxable years beginning on or after January 1, 1996 (Ch. 954, Stats. 1996). However, there was no conformity to Section 404(k) of the Internal Revenue Code for any income year beginning in the 1995 calendar year.

The proposed legislation, which would permit the sale of certain securities without recognizing gain and allow a deduction for certain dividends paid, would operate retroactively to reduce tax revenues with respect to those taxpayers who file an application for refund based upon the proposed legislation.

In this regard, Section 6 of Article XVI of the California Constitution, provides, in part, as follows:

"SEC. 6. The Legislature shall have no power to . . . make any gift or authorize the making of any gift, of any public money or thing of value to any individual, municipal or other corporation whatever"

Generally, pursuant to that provision, the Legislature cannot by a subsequent act surrender, impair, or limit the right of the state to taxes once they have become fixed; for that act, in the absence of a public purpose, is a gift of public moneys and prohibited by the California Constitution (see *Board of Supervisors* v. *Lonergan* (1980) 27 Cal.3d 855, 865 (fn. 10), cert. den., 67 L.Ed. 2d 344; *Estate of Skinker* (1956) 47 Cal.2d 290, 296). In *California Computer Products, Inc.* v. *County of Orange* (1980) 107 Cal.App.3d 731 (hereafter *California Computer Products*), in rejecting a taxpayer's contention that a business inventory exemption expanded by the Legislature after the lien date applied to the taxpayer's escape assessment, the court held, at page 739, as follows:

"... The interpretation advocated by plaintiff would authorize a gift of public funds in violation of article XVI, section 6 of the California Constitution. Where the taxing agency's right to a tax becomes vested, any subsequent legislation reducing the tax by enlarging an exemption, reducing the tax rate, or in any other manner impairing or limiting the right theretofore fixed would constitute a gift of public funds in violation of the state Constitution. (Texas Co. v. County of Los Angeles, supra, 52 Cal.2d 55, 66; Estate of Skinker, supra, 47 Cal.2d 290, 296; Estate of Cooke, 57 Cal.App.3d 595, 603.) . . ."

As a general matter, the right of the state to tax revenues vests when the taxes become due and payable (see *Allen* v. *Franchise Tax Board* (1952) 39 Cal.2d 109, 114). The taxes imposed under the Personal Income Tax Law and the Bank and Corporate Tax Law must be paid at the time and place fixed for filing the return without regard to any extension of time for filing the return (Sec. 19001). With respect to personal income taxes, returns made on the basis of the calendar year are due on the 15th day of April following the close of the calendar year; returns made on the basis of a fiscal year are due on the 15th day of the fourth month following the close of the fiscal year (Sec. 18566). With respect to bank and corporation franchise and income taxes, returns are generally due within two months and 15 days after the close of the

income year (Sec. 18601). Consequently, as to those taxes, returns made on the basis of the calendar year are due on the 15th day of March following the close of the calendar year (Ibid.).

Thus, a statute that would operate retroactively to reduce tax revenues to which the state already has a vested right would constitute an unconstitutional gift of public funds, unless that relief serves a statewide public purpose. In this regard, you have stated that the proposed legislation would contain the following finding and declaration:

"The Legislature finds and declares that employee stock ownership plans (ESOP) broaden ownership of California businesses and that allowing taxpayers that offered ESOP benefits to claim tax relief for the 1995 taxable or income year aids both California workers and businesses."

The constitutional probation against gifts of public funds does not bar the payment of state funds to private institutions or persons for a public purpose that is of statewide interest and concern, even if the private institution or person derives some benefit from the payment (*California Emp. etc. Com.* v. *Payne* (1947) 31 Cal.2d 210, 216).

The court in *California Computer Products*, supra, indicated that the furtherance of a public purpose and the declaration of a public purpose to be served by the Legislature may provide "a sufficient consideration for a tax remission" (Id., at pp. 739–740; see also *Community Television of So. Cal.* v. *County of Los Angeles* (1975) 44 Cal.App.3d 990, 997–998).

The determination of what constitutes a statewide public purpose is primarily a matter for legislative discretion (*Allied Architects' Assn.* v. *Payne* (1923) 192 Cal. 431, 435; *Veterans' Welfare Board* v. *Riley* (1922) 188 Cal. 607) that will not be disturbed by the courts as long as it has a reasonable basis *Nebbia* v. *New York* (1934) 78 L.Ed. 940, 957; *County of Alameda* v. *Carleson* (1971) 5 Cal.3d 730, 746, app. dism., 32 L.Ed. 2d 112). The concept of public purpose has been liberally construed by the courts, and the Legislature's determination will be upheld unless it is totally arbitrary (*Mannheim* v. *Superior Court* (1970) 3 Cal.3d 678, 691). Consequently, any findings and declarations made by the Legislature in an act as to the public necessity for, and public purpose to be served by, a proposed program, while not binding, will be given great weight by the courts (*The Housing Authority* v. *Dockweiler* (1939) 14 Cal.2d 437, 449–450; *County of San Diego* v. *Hammond* (1936) 6 Cal.2d 709, 726).

With regard to a tax refund as a gift of public funds, the court in *Atlantic Richfield Co.* v. *County of Los Angeles* (1982) 129 Cal.App.3d 287 (hereafter *Atlantic Richfield*), in explaining the effect of this constitutional prohibition on a refund of property taxes by a retrospective application of certain statutes, stated as follows:

"[A]s a general proposition the Legislature cannot by a subsequent act increase or decrease the rate, remit the tax or in any way surrender, impair or limit rights that have become fixed and vested. . . . To this general rule, however, there is a well recognized exception. It has been consistently held that expenditures of public funds or property which involve a

benefit to private persons are not gifts within the meaning of the constitutional prohibition if those funds are expended for a public purpose. . . . '[W]here the question arises as to whether or not a proposed application of public funds is to be deemed a gift within the meaning of that term as used in the constitution, the primary and fundamental subject of inquiry is as to whether the money is to be used for a public or a private purpose. If it is for a public purpose within the jurisdiction of the appropriating board or body, it is not, generally speaking, to be regarded as a gift.' (Italics added. Accord: Doctors General Hospital v. County of Santa Clara, 188 Cal.App.2d at p. 286.) It is likewise settled that if a public purpose is served by the expenditure of public funds, the constitutional prohibition is not violated even though there may be incidental benefits to private persons Even more importantly, under an unbroken line of cases the determination of what constitutes a public purpose is primarily a matter for the Legislature, and its discretion will not be disturbed by the courts so long as that determination has a reasonable basis." (Atlantic Richfield, supra, 296–297; emphasis in original.)

In Atlantic Richfield, the court held that the retroactive application of a statute to provide a refund for a tax which had vested in the state had the public purpose of maximizing the recovery of oil and gas, because decreasing the amount of taxes to be paid by the taxpayers would increase their net revenues and encourage the operation of their wells (Atlantic Richfield, supra, 297–298). The court stated further that such public purposes as relieving "hardship" justified this refund. The court also noted other decisions that have upheld, as public purposes, permitting enforcement officers to spend their time on fresh, rather than stale, claims, or returning property to tax rolls (Atlantic Richfield, supra, 298).

Thus, the Legislature, consistent with Section 6 of Article XVI of the California Constitution, may enact legislation that grants retroactive relief from taxation, but only if that relief serves a statewide public purpose. Whether the proposed finding and declaration supports the retroactive relief from tax taxation is a question of fact. We have not been apprised of the specific facts and circumstances, including such matters as revenue impact, affected taxpayers, and the exact nature of the public benefit involved, in order to permit a definitive determination in this respect. However, if the legislative finding and declaration is deemed, pursuant to the deference to the Legislature granted by the courts in this respect, to be accurate with respect to the public benefit to California employers and employees provided by the proposed legislation, then the retroactive tax change would not violate Section 6 of Article XVI of the California Constitution.

Accordingly, we conclude that an amendment to subdivision (a) of Section 18042 of, and subdivision (a) of Section 24611 of, the Revenue and Taxation Code, that would apply those provisions to taxable years

beginning on or after January 1, 1995, and therefore result in the eligibility of certain taxpayers for a refund of taxes for those taxable and income years, would be valid if enacted if those amendments are deemed, as discussed above, to serve a statewide public purpose.
