Legislative Intent—Assembly Bill No. 1458 and Senate Bill No. 853

Dear Members: This letter is to clarify the intent of AB 1458 and SB 853 regarding Fresno County's maintenance-of-effort for transportation. Specifically, the contingency based on the provision of medical care to the indigent should not be seen as requirement for the County to provide identical care to that provided in 2013–14, and the County is not expected to be able to bear medical costs in excess of the amount made available by delaying the maintenance-of-effort (MOE) payment.

State and Federal health care reform shifted patient populations between programs that give low income individuals access to health care. AB 85 (Statutes of 2013, Chapter 24) redirected State health realignment funds because of these changes, but was designed to allow counties to maintain their medically indigent services programs for the remaining population that does not otherwise have access to affordable medical care. Fresno County is concerned the amount of health realignment funding the State is allowing the County to keep may not be enough to provide care to the entire remaining population, especially in the 2014–15 budget year, even though full costs will be reimbursed at the end of 2016. Section 8 of AB 1458 and SB 853 is intended to give Fresno County budget flexibility and cash flow to provide care until the State adjusts the redirection of health realignment funding to meet County costs.

The language in AB 1458 and SB 853 should not be interpreted as preventing Fresno County from changing health care providers for its indigent care program or changing eligibility to exclude patients eligible for full-scope Medi-Cal while still being in compliance with its MOE obligation. This language is also not intended to influence pending litigation regarding care to undocumented individuals. As long as the County continues to provide care, including secondary care, to the population ineligible for full-scope Medi-Cal, as it has been doing for decades, the County will be in compliance with the MOE. The State will pay for care according to AB 85, but if the County's additional costs exceed the \$5.5 million value of the MOE payment, it is not the intent of this legislation to allow the County's fiscal health to be jeopardized. Once the \$5.5 million deferred by this policy is spent on indigent health care, the County should be considered in compliance with the MOE until it is reimbursed by the State for care.

# Legislative Intent—Assembly Bill No. 1928

Dear Mr. Wilson: I am submitting this letter to clarify that Assembly Bill (AB) 1928 is only intended to proscribe the use of coupons for beer products and for products that are advertised in connection with a beer product. Beer products include not only beer, but also cider, perry, and malt beverages. However, cider and perry—both defined as wine products—function as "crossover" products because they are now produced by beer manufacturers, who have been granted special privileges to produce cider and perry, and winemakers.

With regard to cider and perry products, AB 1928 only seeks to regulate those coupons that are offered by beer manufacturers and beer wholesalers. Section 25600.3 of the Business and Professions Code should not be interpreted to mean that winemakers, who produce cider and/or perry and sell either of those products on their licensed premises or to licensees authorized to sell alcoholic beverages at retail, are prohibited from offering, funding, producing, sponsoring, promoting, furnishing, or redeeming any type of coupon. Put differently, winemakers, who produce cider and/or perry, may issue coupons on their cider and/or perry products under this legislation.
