Dear Senators Atkins and Grove, and Assembly Members Rendon and Waldron: Recently, the California Department of Human Resources reached a new Tentative Agreement/MOU with the union representing BU 7, CSLEA. Upon approval of the Legislature and the Governor, and ratification by the membership, this agreement will be effective July 1, 2019 through July 1, 2023.

This agreement will roll over language from past agreements and the attached summary highlights provisions with significant changes. In addition, Unit 7 members will receive a 2.75% General Salary Increase (GSI), effective July 1, 2019, a 2.50% increase, effective July 1, 2020, and another 2.50% GSI, effective July 1, 2021. Effective July 1, 2022, employees will receive either a 2.25% GSI or, a 3.75% GSI, depending on their classification.

In accordance with Government Code sections 3517.5, 19829.5, and Senate Rule 29.4, I am forwarding copies of this Tentative Agreement/MOU, including legislative and fiscal summaries. The Legislative Analyst will be forwarded a copy for analysis, and the Secretary of the Senate and the Clerk of the Assembly will be forwarded copies to note them as available for review in the Daily Journals.

Members of the Assembly: This report presents the results of our high risk audit regarding weaknesses in the State's information security. While we previously found that the California Department of Technology (technology department) has made strides toward improving its oversight, and the state entities it oversees have increased their compliance with established security standards, state entities that fall outside the technology department's purview need to do more to safeguard the information they collect, maintain, and store. State law generally requires state entities within the executive branch that are under the Governor's direct authority (reporting entities) to comply with

the information security and privacy policies that the technology department prescribes and to annually report to the technology department on their compliance. However, state law does not apply the technology department's policies and procedures to entities that fall outside of that authority (nonreporting entities), such as constitutional offices and those in the judicial branch. Consequently, gaps in oversight have contributed to weaknesses in nonreporting entities' information security statuses.

We surveyed 33 nonreporting entities from around the State and reviewed 10 of them in detail. Twenty-nine of the 33 obtained an information security assessment to evaluate their compliance with the specific security standards they selected, 24 learned that they were only partially compliant, and 21 identified high-risk deficiencies. Further, nonreporting entities may be unaware of other information security weaknesses because many of them have relied upon assessments that were limited in scope. For example, five of the 10 nonreporting entities we reviewed had assessed only a portion of their selected standards, and one had neither adopted any standards nor performed any assessments.

Although nonreporting entities are not subject to the technology department's policies and procedures, some are subject to an oversight framework that requires them to assess their information security regularly. This was the case for three of the four entities that had fully assessed their selected standards, leading us to conclude that external oversight improves a state entity's information security status. Accordingly, we recommend that the Legislature amend state law to require all nonreporting entities to obtain or perform comprehensive information security assessments at least every three years and to confidentially submit certifications of their compliance to the Legislature.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report concerning the Fallen Leaf Lake Community Services District (district). This report concludes that the district's billing and budgeting practices and its small electorate jeopardize its ability to provide services. The California Fire Assistance Agreement (fire agreement) between federal and state agencies provides for reimbursement to local fire agencies, including the district, for providing firefighting assistance to federal, state, and other local agencies during wildfires. However, the district claimed excessive personnel costs by inflating its salary rates and

claiming over \$700,000 more than it should have for 2016 through 2018. Without the inflated reimbursements and if the district did not reduce expenditures or increase revenues from other sources, it would have experienced financial shortfalls. Also, the district jeopardized its financial viability because it may have to repay the excessive reimbursement amounts. Furthermore, the district's recent budget practice of counting on these reimbursements—a volatile revenue source—to help cover increases in budgeted personnel costs, adds to the district's financial risk. Separately, limited oversight by the California Governor's Office of Emergency Services of the reimbursement rates that local fire agencies claimed and weaknesses in the fire agreement's reimbursement process also enabled the district to claim the excessive reimbursements.

Additionally, the district's small electorate jeopardizes its ability to continue providing services. The district's board of director's (board) must have at least three members for it to conduct district business, but the district has had difficulty attracting candidates to run for the board. State law requires board members to be domiciled residents in the district and to be registered voters there. We estimate the number of domiciled residents in the district to be between five and 33. Although multiple options exist to address this challenge, redefining the district's electorate to include landowners and other community members, as well as domiciled residents, is the one with the fewest risks and that provides the best opportunity for the district to maintain services and costs at their current levels.

Members of the Assembly: As directed by the Joint Legislative Audit Committee, the California State Auditor performed an audit of the oversight by the Department of Health Care Services (DHCS) of the *Regional Model*, a form of administering managed care to beneficiaries of the California Medical Assistance Program (Medi-Cal) in 18 counties.

This report concludes that DHCS has not ensured that some Medi-Cal beneficiaries in the Regional Model received an acceptable level of care, which we define as adequate access to care combined with adequate quality of care. Specifically, DHCS did not enforce state requirements that limit the distances health plans may direct their Medi-Cal beneficiaries to travel to receive health care. By approving health plans' requests for exceptions to the requirements without validating the reasonableness of those requests, DHCS allowed the

health plans to require some of the Regional Model beneficiaries to travel excessive distances to receive care. DHCS' actions also reduced the health plans' incentives to expand their provider networks to include providers within reasonable distances of their beneficiaries. The Regional Model beneficiaries also generally received a lower quality of care than beneficiaries in other areas of the State, although that quality has recently improved as a result of DHCS' enforcement of the health plans' quality-of-care requirements.

When transitioning the Regional Model counties in 2013 from a fee-for-service delivery system to managed care, DHCS did not adequately assist the counties in identifying the options available to them, despite some counties expressing interest in joining a county organized health system (COHS). The COHS Model, used in 22 other counties in the State, may provide beneficiaries in the Regional Model counties with better access to care than they receive through their current health plans. Establishing a COHS would likely provide the beneficiaries with access to a greater proportion of the Medi-Cal providers in their geographic areas, thereby reducing the distances that the beneficiaries would need to travel to receive care. Because DHCS plans to establish new managed care contracts with the health plans currently serving the Regional Model counties after its current contracts expire in 2023, it is an ideal time for DHCS to evaluate whether the COHS Model would be better suited to provide reasonable access to care and to assist counties with making such a transition if they desire to do so.
