Members of the Assembly:

As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report concerning the University of California (university), focusing on public funding, student fees, and auxiliary enterprises. The report concludes that public revenues increased from \$9.3 billion in fiscal year 2005-06 to \$11.3 billion in fiscal year 2009–10. Revenue from tuition and fees grew the most of any single revenue category due to increased rates and increases in enrollment. This revenue increase along with new revenues from the federal American Recovery and Reinvestment Act of 2009 helped to partially offset the decline in state funding in fiscal years 2008–09 and 2009–10. We also concluded that public expenses, excluding certain retirement expenses, increased from \$8.2 billion in fiscal year 2005–06 to \$9.4 billion in fiscal year 2009-10. The retirement expenses increased by \$3 billion because of a change in accounting rules and updated actuarial valuations.

In addition, the university budgeted widely varying amounts to its 10 campuses. For fiscal year 2009-10, the per-student budget amount ranged from \$12,309 for the Santa Barbara campus to \$55,186 for the San Francisco campus. Although the university identified four factors that it believes contributed to the differing budget amounts, it did not quantify their effects. The university can also improve the transparency of its financial operations. Although the university publishes annually a report of the campuses' financial schedules, it could provide other information including beginning and ending balances for individual funds and could publish consistent information for its auxiliary enterprises. We further reported that the Office of the President needs to more precisely track about \$1 billion of expenses annually that it currently tracks in a single accounting code—Miscellaneous Services and that a recent change in university policy allows campuses to subsidize auxiliary enterprises with funding from other sources, despite the intent that they be self-supporting. Finally, we discovered two instances when the university designated \$23 million in student funding to pay for capital projects on the Los Angeles campus that were not authorized by the student referendum establishing the fee.

Formation of Legislative Records Task Force

Speaker Pérez addressed the assemblage and the following remarks were printed in the Journal:

"Members, I'd like to welcome each of you back from spending time in your districts. I hope you had a productive few weeks meeting with your constituents. Today, I rise to make a brief announcement.

"From the day I was elected Speaker, I have talked about the importance of open government. This is an issue that continues to be of paramount importance to me today. As Speaker, it is my duty to carry out the policies and procedures of the Assembly as established in our internal rules, statutes and the State Constitution. It is also my duty to lead this Chamber forward when those policies need to be updated. That time has come.

"Members from both parties have expressed concerns to me about making Assembly expenditures more accessible. To that effect, I am announcing that Rules Chair Nancy Skinner will lead a task force to review the statutes, rules and procedures governing legislative records. Ms. Skinner will have a proposal to unveil by the beginning of next year's Session. I believe that updating our policies to reflect the 21st century world we live in is a vital step toward that effort.

"How taxpayer dollars are expended is public information, and it is our job to ensure that the public has access to it. Currently, at my direction, all Assembly staff salaries are available on a publicly accessible web site, and we release audits of the Assembly budget annually. The task force, under Rules Chair Nancy Skinner will review our current statutes, rules and procedures, and I look forward to hearing their recommendations and conclusions.

"We have difficult work ahead of us in the next few weeks, and certainly, the efforts to restore health to our struggling economy and create new jobs will continue to be our primary focus for both this year of the Session and next. Thank you."

MESSAGES FROM THE GOVERNOR

Veto Message—Assembly Bill No. 96

Governor's Office, Sacramento July 25, 2011

To the Members of the California State Assembly:

I am returning Assembly Bill 96 without my signature.

The bill would recreate, under a different name, the same Adult Day Health Care (ADHC) program that was eliminated as a Medi-Cal optional benefit through the 2011–12 Budget Act. While my Administration deeply shares the goal of "Keeping Adults Free from Institutions," creating a new ADHC look-alike program at this juncture is unnecessary and untimely. It does not address the immediate need to transition ADHC beneficiaries to other home and community-based services that can meet their needs, and would cause confusion for both consumers and providers about when an ill-defined "KAFI" program would be available.

In order to ensure that ADHC beneficiaries do not face the risk of unnecessary institutionalization when the benefit expires, my Administration is currently working with adult day health centers, managed care plans, and local community-based organizations to ensure that needed medical services and home and community-based services are available. Additionally, in order to ensure that there is enough time for transition to such services, the Department of Health Care Services recently extended the ADHC benefit through administrative action until December 1, 2011, with federal funding approval.

Given the importance of these transition efforts, I am directing the Department of Health Care Services to work with the Legislature, stakeholders, managed care plans, and home and community-based services providers to ensure that ADHC beneficiaries will have a smooth transition to appropriate services, and those who are most at risk of institutionalization have access to services that will help them remain in the community.

Care in an integrated setting will be part of my Administration's plan to improve long-term care. To the extent that adult day health care-type services can become part of an integrated continuum of care, my Administration will work to bring such providers into the conversation on how these services can be efficiently and effectively delivered for the benefit of consumers.

For this reason, I am signing Senate Bill 91, which will allow adult day health centers to continue to operate after the fee-for-service payments under Medi-Cal expire. This will allow adult day health centers to be considered a care option as part of an integrated delivery system, or for consumers who may wish to access services apart from Medi-Cal.

Veto Message—Assembly Bill No. 455

I am returning Assembly Bill 455 without my signature.

This bill prescribes how all local merit or personnel commission members should be appointed. It requires that half of the members be selected by the employer and half by largest employee bargaining unit.

While intended to create more balanced commissions and address concerns relating to individual commissions, this measure imposes a top down, one-size-fits-all solution on all merit and personnel commissions statewide.

This measure seeks to impose a level of state control that is inconsistent with my administration's efforts to realign state services and to increase local control. Concerns relating to specific commissions should be addressed on a case-by-case basis at the local level.

This measure requires all state agencies and departments to post examination and vacancy announcements on the State Personnel Board's website. It also requires that the names of employees that are laid off from *department specific* job classifications be placed on "comparable" statewide reemployment lists.

While I support the author's intent to increase access to state employment opportunities for laid off state employees, this measure fails to provide adequate protections against an unqualified employee being misplaced on a comparable statewide list. Further, it may delay the layoff process and reduce the anticipated savings from future layoffs.

I note that the state departments and agencies working in conjunction with the Department of Personnel Administration currently have the authority to work collaboratively to designate comparable classes on a case-by-case basis as a part of layoff negotiations with employees and their representatives. Further, I encourage all parties to engage in this process whenever possible during these difficult fiscal times for the state, its employees and all Californians.
