Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its report concerning our review of the Public Utilities Commission's (commission) consultant contract for investigating San Francisco's 1998 power failure.

The report concludes that the commission inadequately monitored the contract as it did not evaluate the qualifications of the consultant's subcontractors who performed investigative work. In addition, the commission did not make certain that the consultant's report contained sufficient detail and analysis to support all of the report's conclusions. Further, the commission cannot substantiate the amount of the contract

and has not required the consultant to submit invoices. As a result, the commission has not ensured that the consultant's expenditures have been appropriate and within budget.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its report concerning the State's administration of the Carl D. Perkins Vocational and Applied Technology Education (Perkins) program, and how the California Department of Education's (department) 1995 reorganization of its Curriculum and Instructional Leadership Branch affected its ability to administer the program.

This report concludes that both the department and the Chancellor's Office of the California Community Colleges (Chancellor's Office) used Perkins funds to administer other federal and state programs that are similar to the Perkins program. Furthermore, although Perkins funds have increased over the past five years, the department, since reorganizing in 1995, reduced its staff working on the Perkins program in the Secondary Education Division, which administers the majority of the program. This reduction resulted in diminished services to school districts providing vocational education programs. While federal guidelines do not appear to allow the State to use Perkins funds to administer other programs, more importantly, the department and the Chancellor's office have not maximized the effectiveness or availability of Perkins vocational services at the local level. As a result, students may be inadequately prepared to meet the needs of today's high technology society.

Dear Members of the Assembly: As required by Chapter 880, Statutes of 1998, the Bureau of State Audits presents its audit report concerning the current generator fee structure prescribed in Section 25205.5 of the California Health and Safety Code and the hazardous waste fees charged by local Certified Unified Program Agencies (CUPAs) pursuant to Section 25404.5 of the California Health and Safety Code.

This report concludes that the generator fees, which are set in statute, are not fair and reasonable for all levels of hazardous waste generators. Further, the Department of Toxic Substances Control's efforts to encourage recycling in the State and to penalize businesses that do not recycle waste that could be recycled are minimal.

Although services the CUPAs and the State provide do not overlap, some aspects of the Unified Hazardous Waste and Hazardous Materials Management Regulatory Program are not being implemented. Specifically, some CUPAs have not implemented all six mandatory program elements and 15 counties in the State do not have a CUPA. Finally, state agencies responsible for overseeing certain regulatory programs are not assuring that all program elements are being implemented in counties that do not have a CUPA.

Members of the Assembly: As part of our annual financial and compliance audit of the State of California for the fiscal year ended June 30, 1999, required by Section 8546.3 of the California Government Code, the Bureau of State Audits presents its audit report concerning the management of overtime expenditures among state departments. This report concludes that several state departments could do more to reduce the incidence of overtime paid to their employees. Large amounts of overtime earned by State employees can be more costly than hiring additional employees, and can lead to increased use of employee sick leave, more workplace injuries, added disability claims, and loss of productivity. Our review disclosed that one department relied heavily on overtime to cover staffing shortages due to vacations, training, and other absences rather than using other less costly alternatives. We also identified other departments that inappropriately paid overtime to employees who are not eligible for overtime pay. Finally, we observed that some departments did not always comply with their own internal controls for the proper administration of overtime.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the Medi-Cal Managed Care Two-Plan Model (two-plan model) and its impact on quality of and access to health care. The two-plan model is a method of operating managed care in which the Department of Health Services (department) contracts with two health plans in each county to provide care.

This report concludes that based on limited available data, the department's implementation of the two-plan model does not appear to have an adverse impact on the quality of and access to medical services provided to the Medi-Cal population. To ensure that health plans are providing high quality an easily accessible medical services, the

department monitors the health plans. However, the department's monitoring efforts thus far have been incomplete because its approach for monitoring health plans is not well organized.

This report concludes that the department's monitoring efforts failed to detect unsubstantiated claims for adult education funds submitted by community-based organizations. In addition, the department's award process yielded inconsistent decisions that leave it open to charges of favoritism. The department is making significant changes to the adult education program. However, the changes may not resolve past problems and could result in a drop in the number of students served.

Members of the Assembly: The Bureau of State Audits presents its audit report concerning the Department of Health Services' (department) Forensic Alcohol Program titled *Department of Health Services: The Forensic Alcohol Program Needs to Reevaluate Its Regulatory Efforts*. This audit was conducted to follow up on issues identified during our 1998 audit of the 19 local forensic laboratories.

This report concludes that the department's regulatory efforts primarily emphasize reviewing written methods. Although necessary and important, the reviews are not completed promptly and focus on issues that do not improve the labs' analyses. Further, while the department also conducts periodic site visits and proficiency tests, a greater emphasis on these activities may be more beneficial to the labs

than method reviews. Finally, the department's requirements for training operators of breath-alcohol analysis equipment are unnecessarily restrictive.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning our review of California's Child Support Enforcement Program (CSEP). This report concludes that the CSEP in California is disjointed, complicated, and lacking in leadership. More specifically, the Department of Social Services (DSS) is the agency solely responsible for administering, supervising, and monitoring the CSEP at the statewide level, yet it has not provided the counties that manage the CSEP locally with the leadership, assistance, and direction needed to ensure the program's effective operation. Furthermore, we believe that DSS's failure to provide strong leadership, combined with a disparate delivery of services by the 58 district attorneys' county-based programs, has severely limited California's success with its CSEP.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning conflict resolution programs and related best practices that California public schools have in place to prepare themselves for conflict between students, students and the school, and parents and the school.

This report concludes that more than 75 percent of schools have a conflict resolution program, however; few have programs where the entire school community—principals, teachers, vice principals, students, other staff, and parents—learns and adopts conflict resolution

techniques. Principals of schools with comprehensive programs that train most of the school community feel their schools are better prepared to handle conflicts than those with limited programs which train few. Therefore, schools would benefit by enhancing existing programs or implementing programs where most of the school community is exposed to conflict resolution. While schools use varying resources to support programs aimed at reducing school violence, many schools rely on district general funds. Furthermore, recent legislation provides \$100 million for school safety programs; however, schools must still decide whether they will devote any of the money to conflict resolution programs.

It is my understanding from the California Arts Council, that the funds will be distributed after December 1999. The Council also informed me that they will conduct a workshop for recipient organizations regarding the procedure to request funding prior to December.
