**MESSAGES FROM THE GOVERNOR**

The following veto message from the Governor was received and ordered printed in the Journal and the bill ordered to the unfinished business file:

**Veto Message—Assembly Bill No. 2194**

Governor's Office, Sacramento

August 16, 1998

*To the Members of the California Assembly:*

I am returning Assembly Bill No. 2194 without my signature.

This bill would extend until August 1, 2004, the authority of the South Coast Air Quality Management District (District) to collect an additional one-dollar fee on motor vehicle registration renewals within its jurisdiction.

Reauthorization of this fee is inconsistent with recent efforts to reduce vehicle registration taxes. Its imposition would place an additional \$10 million burden on taxpayers within that District each year, or \$50 million over the life of the extension.

The one-dollar surcharge affected by this bill is in addition to a separate four-dollar surcharge the District is authorized to impose on motor vehicle renewals to fund programs to reduce pollution from mobile sources. This levy provides the District with approximately \$40 million each year. To the degree the District believes that the projects funded by the one-dollar surcharge are worthy of continued investment, it should consider funding them from the revenues generated by the four-dollar surcharge.

**MESSAGES FROM THE GOVERNOR**

The following veto messages from the Governor were received and ordered printed in the Journal and the bills ordered to the unfinished business file:

**Veto Message—Assembly Bill No. 183**

Governor’s Office, Sacramento

August 17, 1998

*To the Members of the California Assembly:*

I am returning Assembly Bill No. 183 without my signature.

The bill would create a Motor Vehicle Owners’ Rights Advocate for the Bureau of Automotive Repair (BAR) to act as the principal proponent for consumers who register automotive complaints related to the Smog Check Program.

This bill is unnecessary. The Advocate is superfluous to the existing responsibilities of the BAR Chief and the Director of the Department of Consumer Affairs. There is no empirical evidence that demonstrates the need for a person solely dedicated to monitoring the resolution of complaints. Moreover, should a need arise, there is nothing to prevent the Director from assigning someone to assume these responsibilities on an ad hoc basis until the concern has been dealt with. The mandated establishment of the Advocate position would simply add an

unnecessary, unfunded position and corresponding staff to review the existing complaint mediation structure when such powers already reside with the Department Director.

**Veto Message—Assembly Bill No. 901**

Governor's Office, Sacramento

August 17, 1998

*To the Members of the California Assembly:*

I am returning Assembly Bill No. 901 without my signature.

This bill would require the California State World Trade Commission, within the California Trade and Commerce Agency, to prepare a State Strategic Plan for International Trade Promotion, to be submitted to the members of the Legislature, the Governor, the Lieutenant Governor, and the Secretary of State no later than January 31, 2000. The bill would require the plan to be updated every four years.

The Trade and Commerce Agency currently has a strategic plan that includes an international trade component. The Division of International Trade and Investment within the agency currently explores opportunities for expansion and analyzes trade policy issues on a continual, as-needed basis, and prepares an annual report that includes the World Trade Commission's trade policy activities. The division's programs are evaluated annually and the future direction is selected through the budget process.

This bill codifies in statute a short-sighted prescription for strategic planning. The Agency needs to maintain its flexibility to stay abreast of the ever-changing global trade environment. These tasks can and should be accomplished without placing complex reporting requirements in statute.

**Veto Message—Assembly Bill No. 2020**

Governor's Office, Sacramento

August 17, 1998

*To the Members of the California Assembly:*

I am returning Assembly Bill No. 2020 without my signature.

This bill would prohibit a common interest development (CID) from prohibiting the owner of a separate interest from keeping a pet if the owner is disabled or regarded by a licensed physician or psychologist as needing a pet.

Common interest developments use covenants, conditions and restrictions (CC&Rs) to govern the development and maintenance of common areas. These CC&Rs represent a set of terms of a private contract between knowing adults.

The Supreme Court has validated the concept that CC&Rs are private contracts between homeowners and their associations. While evidence suggest that pets enhance the quality of life for many seniors and disabled persons, the resolution of any conflict should come through the

homeowner association board of directors and the homeowners rather than through a bill that interferes in those private contracts.
