REQUEST FOR UNANIMOUS CONSENT TO PRINT IN JOURNAL

Dear Mr. Mallory: I introduced Senate Bill 1987 at the behest of constituents and with the cooperation of the Senate Select Committee on Mobile and Manufactured Homes to clarify that Health and Safety Code Section 18603 requires the responsible person in a mobilehome park to not just be "available" but reasonably respond in a timely manner to emergencies in the park.

The bill has been amended a number of times in order to satisfy both the mobilehome owners (GSMOL) and the park owners (WMA and MPA), and the June 8th version, enclosed, is now without opposition. However, Assemblymember Aroner raised a question in the Assembly Housing Committee on June 17th concerning whether the term "emergency" should be defined in statute or at least by regulation. As indicated by Assemblymember Bill Morrow, who took the bill up for me in committee, I would prefer not to change SB 1987's language, since the park owners have told me they may oppose the bill if I "tinker" with the word emergency in statute. This puts me in sort of a "Catch 22." However, we agreed in committee to request the Department to define the word "emergency" for purposes of Health and Safety Code Section 18604 by administrative regulation, and I hereby notify you formally of this request.

John Tennyson, consultant to the Select Committee, has already spoken to Paul Deiro of your staff about this matter. Your consideration

of my request will be appreciated. If you need any further information in this regard, please call John at 324-4282.

REQUEST FOR UNANIMOUS CONSENT TO PRINT IN JOURNAL

Legislative Intent—Assembly Bill No. 871 and Senate Bill No. 1898

Dear Mr. Wilson: The purpose of this letter is to clarify the intent and legal effect of one subsection included in both Assembly Bill 871 and Senate Bill 1898. The pertinent language modifies Section 33459.1(b)(3) of the Health & Safety Code as follows:

“Any action taken by the agency pursuant to this paragraph shall be consistent with any agreement between the agency and the responsible party and with the requirements of the state or local agency that approved or will approve the preparation and implementation of the remedial action plan.”

The intent of the above language is to require that any action taken by the agency be consistent with the regulatory authority of the state or local agency that approved or will approve the remedial action plan. The intent of the language is not to suggest that any existing requirements of the state or local agency as to the subject property, or the absence of any such requirements, limit, restrict or modify the agency’s ability to undertake an action that is otherwise consistent with this Bill and the state or local agency’s regulatory authority.

House Resolution No. 73

By Assembly Member Villaraigosa

Relative to commending the Honorable Liz Figueroa.

WHEREAS, The tenure of Assembly Member Liz Figueroa with the California State Assembly is drawing to a close following four years of exemplary service, and it is appropriate at this time to highlight her many achievements and to extend to her the highest commendation; and

WHEREAS, Liz Figueroa was first elected to the California State Assembly in November 1994 as the representative of the 20th Assembly District; and

WHEREAS, She is the first Northern California Latina to be elected to the California State Assembly in this century, and her parents are both from El Salvador; and

WHEREAS, Assembly Member Figueroa was born and raised in the San Francisco Bay Area and attended the College of San Mateo; at 18 years of age, she was the youngest person to be appointed to serve on the San Mateo Human Relations Commission; in 1985 she was the recipient of the Outstanding Young Woman of America Award; prior to serving in the Assembly, she owned and operated Figueroa Employment Consultants, a business that specialized in placing injured workers in jobs, for 17 years; and in 1985 she was appointed to the Board of Directors of the Union Sanitary District and served as the first female president in its 71-year history; and

WHEREAS, Assembly Member Figueroa is Chairperson of the Assembly Insurance Committee and the Assembly Select Committee on Aerospace, and a member of the Assembly Committees on Budget, Consumer Protection, Governmental Efficiency and Economic Development, Health, Judiciary, Transportation, and the Assembly Select Committee on Education Technology, and is also the Speaker's appointee to the California Commission on the Status of Women; and

WHEREAS, At the end of her first term, nine of her bills reached the Governor's desk, all of which were signed into law—the highest percentage of any freshman legislator; she consistently has carried legislation that demonstrates her dedication to serving the needs of her constituents—improving access to and the quality of health care, streamlining business regulations, and protecting consumers; in 1996 she worked with The White House on landmark legislation that ensured a two-day hospital stay for mothers and their newborns; in 1997 she co-chaired the conference committee that drafted major legislation, relating to Healthy Families, to provide health insurance for the children

of the working poor; and her work on behalf of women and human rights has gained international recognition; and

WHEREAS, In 1997 Assembly Member Figueroa was named Legislator of the Year by eight organizations; the American Electronics Association named her Legislator of the Year three years in a row; she has authored several bills to help her high-tech constituency; and she successfully fought to include research and development tax credits for aerospace and high-tech firms each year in the state budget; and

WHEREAS, Through her professional, public, and community activities, Assembly Member Figueroa has made a significant impact on the people of the 20th Assembly District and throughout the state, and she will be sorely missed by those individuals with whom she has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That they take great pride in honoring Assembly Member Liz Figueroa for her outstanding service to the residents of the 20th Assembly District and the people of California during her tenure as a Member of the Legislature, and extend to her heartiest best wishes for happiness and success in her future endeavors.

WHEREAS, He is an active member of the San Luis Obispo County Agriculture Task Force and the County Farm Bureau, and before his election, he served as a board member of NCI Affiliates, a nonprofit Paso Robles corporation which serves developmentally disabled adults; and

WHEREAS, Mr. Bordonaro was formerly the general manager of Bordonaro & Sons Construction and holds California Real Estate and Tax Preparation Licenses; and

WHEREAS, Assembly Member Bordonaro is a quadriplegic, having suffered a severe, almost fatal cervical spinal injury in 1977 at the age of 18; and

WHEREAS, With a “can do” attitude, he went on to graduate magna cum laude from California Polytechnic State University, San Luis Obispo, in 1983, and he received his degree in agricultural management and was named the university’s Disabled Student of the Year for 1982–83; he later attended the University of California, Davis, where he received his master’s degree in agricultural economics in 1986; and

WHEREAS, Through his professional, public, and community activities, he has made a significant impact on the people of the 33rd Assembly District and throughout the state, and he will be sorely missed by those individuals with whom he has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That they take great pride in honoring Assembly member Tom Bordonaro for his outstanding service to the people of the 33rd Assembly District and the people of California during his tenure as a Member of the Legislature, and extend to him heartiest best wishes for happiness and success in his future endeavors.

One of only four sports writers to ever win a Pulitzer Prize, Murray has also been inducted into the Baseball Hall of Fame.

Known for the wry humor of his columns, Murray wrote in his autobiography, "Satire is the best weapon in the writer's arsenal to attack injustice."

Although famous for the "one-liners" in his column, readers were often touched most deeply by the columns that were about Murray's personal life.

When Murray's first wife, Gerry, died in 1984 after 38 years of marriage, Murray wrote that he had planned a speech for their 39th anniversary that he never had a chance to deliver.

"I was going to tell her: 'It was a privilege to have known you.' "

To Jim Murray we say, "It was a privilege to read you."

The great editor E. B. White once wrote that it was a rare thing to know someone who was both a great writer and a great friend.

Today, Los Angeles has lost both.
