RE: Tentative Agreements/Memoranda of Understanding (MOU's) for California Attorneys, Administrative Law Judges and Hearing Officers in State Employment (CASE) Representing Bargaining Unit 2

Dear Senators Steinberg and Huff, and Assembly Members Atkins and Conway: Recently, the Department of Human Resources (CalHR) reached a new Tentative Agreement/MOU with CASE representing Bargaining Unit 2—attorneys, administrative law judges and hearing officers. Upon approval of the Legislature and the Governor, and ratification by the membership, this agreement will be effective July 2, 2013 through July 1, 2016.

The agreement will rollover language from past agreements and makes changes primarily in the area of employee compensation.

In accordance with Government Code Sections 3517.5, 19829.5, and Senate Rule 29.4, I am forwarding a copy of the Tentative Agreement, including a legislative and fiscal summary. The Legislative Analyst will be forwarded a copy for analysis, and the Secretary of the Senate and the Clerk of the Assembly will be forwarded copies to make them noted as available for review in the daily journals.
