Dear Mr. Speaker: I respectfully request this letter be entered into the Assembly Journal to clarify the legislative intent of AB 2403.

AB 2043 makes it a crime to install or permit the installation of a camera in a house or apartment to surreptitiously view someone with the intention of invading their privacy, and criminalizes the dissemination of pictures taken in this way.

It is not the intention of this legislation to criminalize surreptitious videotaping when the person who is the subject of the videotape later consents voluntarily.
