WHEREAS, First elected to the California State Assembly in 1994, Steve Baldwin wasted no time in pursuing his goal of improving public education in California, and during his term as Chairman of the Assembly Education Committee he advocated for and supported quality education that children should receive in the California public schools; and

WHEREAS, He carried the majority of the major charter-school legislation, which gives more flexibility to teachers and parents to see that children get the best education possible; and

WHEREAS, Assembly Member Baldwin shepherded funding equalization measures through the Education Committee, which resulted in equalizing funding between "high" and "low" wealth districts, and all San Diego County districts received a funding boost as a direct result of this measure; and
