Dear Mr. Wilson: I introduced AB 902 in response to concerns raised about the need to protect subcontractors by preventing "bid shopping and bid peddling." The express legislative purpose for the listing law is to protect subcontractors by preventing "bid shopping and bid peddling" of their bids after bid day (Public Contract Code § 4101). AB 902 is simply intended to clarify existing listing law.

The goal of the listing law is achieved by requiring the prime contractor bidders, first, to list proposed subcontractors, and then, to give them subcontracts for the work. In other words, a subcontractor is supposed to get a subcontract for the scope of work it bid upon and was listed for. Unfortunately, some local agencies believe that the language of section 4101 is susceptible to an interpretation that the prime contractor bidder can submit a subcontract to a subcontractor that picks and chooses among the elements of the subcontractor's bid, and, if the subcontractor does not consent to those changes in its bid, then the prime contractor can go to others to perform the work. Such an interpretation vitiates the listing law. It allows prime contractor bidders to shop and peddle subcontractor bids after bid day, and, if they find a cheaper price for all or part of the work, to subvert the listing law by offering the listed subcontractor a subcontract that differs from that subcontractor's bid.

Finally, that erroneous interpretation of the listing law would defeat the whole purpose of that statute. AB 902 is designed to make the language more clear, so there is no doubt of what has always been required by the listing law.

Dear Mr. Wilson: On July 16, 2003, AB 226 (Vargas) was amended in the Senate to modify the notice requirements for holders of corporate owned life insurance policies specified in Section 10110.4(f). Specifically, the July 16, 2003, amendment to Section 10110.4(f)(3) provides that an employer does not need to disclose the benefit amount under a corporate owned life insurance policy described in Section 10110.4(f) if the full amount of the benefit is used to defray the costs of nonexempt employee benefits. The intent of this letter is to clarify that the exemption for disclosing the benefit amount applies where the full amount of the benefit is used to defray the aggregate costs of current and anticipated future benefit liabilities of non-exempt employees of that employer.
