PRAYER

Upon invitation of Speaker pro Tempore Lowenthal, the following prayer was offered by Reverend Patti Oshita:

Like Mr. Nakanishi, who is the 17th generation caretaker of his family's tradition, we are all the momentary caretakers of a dream that has been unfolding for 249 years, since 1776. Let us continue to try our best to keep this dream alive, and the beacon that is America, shining bright.
