At 2:13 p.m., a special ceremony was convened to honor Members retiring from the California State Assembly.

House Resolution No. 75

By Assembly Member Hertzberg

Relative to commending the Honorable Kerry Mazzoni

WHEREAS, The Honorable Kerry Mazzoni, who has represented the 6th Assembly District for the past six years, and due to term limits is retiring as an Assembly Member, and it is appropriate at this time to highlight her many achievements and to commend her for her illustrious record of service to the State of California; and

WHEREAS, Kerry Mazzoni was first elected to the California State Assembly in 1994, and since that time, she has represented the residents of the 6th Assembly District, which includes all of Marin County and the southern portion of Sonoma County; and

WHEREAS, Her legislative agenda has focused on educational reform, and during her service as Chair of the Assembly Education Committee, she played a critical role in shaping many of the education reforms that have altered the landscape of education in the State of California; and

WHEREAS, Assembly Member Mazzoni has demonstrated her lifelong commitment to public education and to providing all children with the tools necessary to be productive and contributing citizens through her efforts in education reform, including her leadership in establishing a comprehensive, statewide accountability system, and her efforts to secure the Class Size Reduction, Kindergarten-University Public Education Facilities Bond Act of 1998; and

WHEREAS, She advocated tirelessly to make smaller class sizes the cornerstone of the state's focus on education and provided opportunities for retired teachers to return to the classroom; she carried legislation that focused on quality reading programs that change the manner in which reading is taught and established training programs in reading and mathematics instruction for teachers; she stressed early childhood education by addressing the entry age of kindergartners; and her legislation provided teachers with support and training necessary to demonstrate basic competence in computer skills, provided greater funding equity among school districts, and restricted the commercialization of California schools in instructional materials; and

WHEREAS, Assembly Member Mazzoni's other accomplishments during her tenure in the legislature include drafting the Mazzoni Long Term Care Act of 2000, which created the Health and Human Services Agency's Long-Term Care Council, successfully carrying legislation to authorize local needle exchange programs, securing over \$5 million in funding to expand Tomales Bay State Park at Millerton Point in West Marin, securing \$4 million in state funds for the Bolinas Lagoon Restoration Project, leading the project to build a median barrier on Highway 37 which has prevented further fatalities, securing \$500,000 in state funding for breast cancer research in Marin County,

securing \$250,000 in state funding for the Marin Brain Injury Network, and working diligently to secure state funds to augment child care programs; and

WHEREAS, Assembly Member Mazzoni has distinguished herself through her service as Chair of the Women's Legislative Caucus, Co-Chair of Joint Ethics, Chair of the Special Committee on School Facilities Finance and the National Conference of State Legislators Education Committee, Vice Chair of the Education Committee, a member of the Select Committee on California Wine Production and the State Allocation Board, and as a member of numerous Assembly Committees that includes Banking and Finance, Housing and Community Development, Transportation, Utilities and Commerce, Governmental Organization, Natural Resources, Health, and Judiciary; and

WHEREAS, Assembly Member Mazzoni has made constituent services a top priority by focusing on the needs of the community and its individuals, always remembering that she was elected to represent those interests; and

WHEREAS, Assembly Member Mazzoni has established a reputation, both in her district and the Capitol, as a legislator who believes deeply in the dignity of each human being; valuing every person as an individual and celebrating their different perspectives, as she embraces the task of finding common ground on which to build solutions; and

WHEREAS, Assembly Member Mazzoni is widely respected by both her constituents and her colleagues for her intelligence, graciousness, humanity, integrity, and courage; and

WHEREAS, Through her professional, public, and community activities, Kerry Mazzoni has made a significant impact on the people of the 6th Assembly District and throughout the state, and she will be sorely missed by those individuals with whom she has been associated; now, therefore, be it

House Resolution No. 88

By Assembly Member Hertzberg

Relative to commending the Honorable Howard Kaloogian

WHEREAS, The Honorable Howard Kaloogian, who has served the 74th Assembly District for the past six years, has announced his retirement as an Assemblyman, and it is appropriate at this time to acknowledge his many achievements and to commend him for his illustrious record of service to the State of California; and

WHEREAS, First elected to the California State Assembly in 1994, Howard Kaloogian of Carlsbad has served three terms in the California Legislature, where he has been a leading voice for a smaller and more responsive government and has been recognized for his consistent efforts to reform tax laws, and has led Republican tax reformers as Vice Chair of the Revenue and Taxation Committee; and

WHEREAS, Assemblyman Kaloogian has been entrusted with the responsibilities of higher leadership; in his first term, he was named Chair of Budget Subcommittee on Resources, and he was named Chair of the Assembly Public Employees, Retirement and Social Security Committee, making him the first Republican to chair that policy committee managing the retirement system for public employees, and in his second term, he was Assistant Leader of the Assembly Republican Caucus, he was also named Vice-Chair of the Assembly Banking and Finance Committee; and

WHEREAS, Assemblyman Kaloogian authored the nation's first portable retirement option giving public employees a choice to control their own pension accounts; and he passed model legislation through the American Legislative Exchange Council (ALEC), creating public employee defined contribution pension plans, which has now passed in Michigan, Florida, Ohio, and eight other states, is introduced in 19 other states, and is recognized as driving the current social security reform debate; and

WHEREAS, During his service on the Local Government Committee, Assemblyman Kaloogian reviewed the regulation of local and county jurisdictions and the administration of special districts, and he worked to enforce the people's will in protecting Proposition 218, which prevents fees and assessments from being levied without a two-thirds vote of the people; he has consistently and convincingly has

argued, both in his county and in the state house, that local services must be placed on the most responsible fiscal footing; and

WHEREAS, He has been a member of the Assembly Human Services Committee monitoring California's welfare-reform effort and also has served on two special panels, the Select Committee on California-Mexico Affairs and the Select Committee on California Horse Racing Industry; and

WHEREAS, Assemblyman Kaloogian has also served as a member of the Governmental Organization, Judiciary, and Health Committees; and

WHEREAS, He has authored measures that promote public health, strengthen criminal justice, improve the state's business climate, promote the restoration of the California coastline, and foster fiscal responsibility in state government; and

WHEREAS, Assemblyman Kaloogian is proud of his Armenian heritage, he has honored the history of his people, leading the Legislature to annually commemorate and condemn the Armenian Genocide, recognized the Republic of Karabakh's independence, and called upon all nations to never again engage in crimes against humanity; and

WHEREAS, Upon learning of the suffering of the persecuted Sudanese, he lead the Legislature to condemn the current government of Sudan for its ongoing genocidal war in Southern Sudan, support for terrorism, and continued human rights violations; and

WHEREAS, Assemblyman Kaloogian has steadfastly advanced a culture that honors life, he has received recognitions and awards from statewide and national pro-life organizations; and

WHEREAS, An effective advocate of education reform, Assemblyman Kaloogian authored the first comprehensive parental rights law in the nation, providing parents tools to be an integral part of their child's educational process; and

WHEREAS, Assemblyman Kaloogian has received an "A+" rating from Citizens Against Lawsuit Abuse and a 100 percent pro-business voting record as recognized by the California Chamber of Commerce and the National Federation of Independent Business; he was honored by the American Legislative Exchange Council (ALEC), which named him Legislator of the Year for the entire nation in 1996, and he holds several awards and honors for his exemplary public service; and

WHEREAS, He is a member of the Board of Directors of the Coalition to Improve Education and a member of the American Council of Young Political Leaders and of the Atlantic Bridge, and he has served as California Chair of the National Conference of State Legislatures (NCSL) and has been a featured speaker at both the ALEC and NCSL national conventions; and

WHEREAS, Assemblyman Kaloogian was born and raised near Detroit, Michigan, graduated from Michigan State University with a dual bachelor's degree in political science and business, received his law degree from Pepperdine Law School in 1984, was admitted to the Michigan State Bar in 1984 and the California State Bar in 1985, and spent 11 years in private law practice and owned his own practice for eight years, specializing in taxes, probate, trusts, and elder law, and is licensed to practice law in California and Michigan as well as before the United States Tax Court; and

WHEREAS, Through his professional, public, and community activities, Howard Kaloogian has made a significant impact on the people of the 74th Assembly District and the people of California, and he will be sorely missed by his constituents and by those with whom he has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That the Honorable Howard Kaloogian be honored for his outstanding service to the people of the 74th Assembly District and the people of California during his tenure as a Member of the California Assembly, and he be extended the heartiest best wishes for happiness and success in his future endeavors; and be it further
