Members of the Assembly:

As authorized by Chapter 251, Statutes of 2004, the California State Auditor presents this audit report assessing high-risk issues the State and selected state agencies face. Systematically identifying and addressing high-risk issues can contribute to enhanced efficiency and effectiveness by focusing the State's resources on improving the delivery of services related to important programs or functions.

We have added the California State Teachers' Retirement System's (CalSTRS) Defined Benefit Program to the high-risk list. Contribution rates for teachers and administrators, which can only be changed through legislation, have not changed in decades and are currently not sufficient to ensure the payment of all promised future benefits. Currently the Defined Benefit Program is funded at 71 percent, well below the 80 percent considered necessary for a sound pension plan. Unless the State takes steps, such as raising the contribution rates of CalSTRS members and their employers, it may be responsible for providing the necessary funding using taxpayer money.

We believe that the State continues to face eight other significant high-risk issues: addressing the budget deficit, funding retiree health benefits, ensuring timely expenditure of the American Recovery and Reinvestment Act of 2009 funds, upgrading and expanding the State's infrastructure, ensuring a stable supply of electricity, effectively strengthening the State's workforce, preparedness, and providing effective oversight of the State's information technology projects. We further believe that three state agencies continue to meet our criteria for high risk as they face challenges in their day-to-day operations: the California Department of Corrections and Rehabilitation, the California Department of Health Care Services, and the Department of Public Health.

We will continue to monitor the risks we have identified in this report and the actions the State takes to address them. When the State's actions result in significant progress toward resolving or mitigating these risks, we will remove the high-risk designation based on our professional iudgment.
