Dear Ms. Parker: As the author of AB 2251, I am providing this letter to the Assembly Daily Journal to clarify my intentions related to the statewide strategic plan detailed in section 4799.10.2 (a) (1) of the bill. This section states:

“The department shall complete a statewide strategic plan, in consultation with nonprofit organizations, cities, counties, other local governments of urban areas, and disadvantaged and low-income communities, to achieve a 10-percent increase of tree canopy cover in urban areas by 2035, with priority for increasing tree canopy cover in disadvantaged and low-income communities and low-canopy areas.”

It is my understanding that there is some confusion on the scope of the 10% increase of tree canopy cover cited in AB 2251. My intent was to have the bill require the strategic plan to achieve a 10% increase of tree canopy cover above current levels of existing tree canopy cover in our state’s urban areas.

I trust that this clarifies the questions that have arisen.
