One of my favorite Japanese haiku poems captures the contemplative nature of autumn. Haiku, as many know, is the shortest structured form of poetry and has only 17 syllables. We can almost feel a sudden gust of wind causing the leaves to float to the ground. This haiku reflects the naturalness of constant change. All things must pass.

Knowing that nothing is forever, opens our Wisdom Eyes; and we are reminded to try to live not taking for granted the days we are able to enjoy, or the moments we are able to be with the people we love. With Wisdom Eyes open, we begin to live with ever-deepening appreciation.
