> RE: AB 989 (Lowenthal), Coastal Commission Recordings: Prospective Nature of Bill

Dear Mr. Speaker: I have authored AB 989 to give the California Coastal Commission the authority to record against the property of an owner who has violated the California Coastal Act. The bill provides due process for the property owner and expedites recission of the recording once the violation has been resolved. It also provides constructive notice to potential purchasers of the property that there is a pending violation.

During the course of the legislative process, there has been some confusion about whether the provisions of AB 989 could be applied to violations occurring prior to its effective date. In fact, during the Assembly Natural Resources Committee hearing, I took author's amendments striking language that stated the bill was prospective only.

Since that time, Legislative Counsel has informed me that it would be unconstitutional to apply the provisions of AB 989 retroactively. It is for this reason that I submit this letter to you now, expressing my intent that the provisions of AB 989 are prospective only. The bill is not intended to apply to any violation prior to its operative date.

Thank you for printing this letter in the Assembly Journal on this date, prior to the Senate Floor vote on AB 989.
