Jacob Riis was a turn of the century photojournalist whose work focused on exposing the plight of the urban poor in America. He once reflected on what he would do when he was feeling discouraged. He said:

When nothing seems to help, I go and look at a stonecutter hammering away at his rock perhaps a hundred times without as much as a crack showing in it. Yet at the hundred and first blow it will split in two, and I know it was not that blow that did it—but all that had gone before.

So often in life it feels as though there is no end to our labors, and that our goals might not be realized. But there is something to be learned from the story of the stonecutter. It reminds us to be patient with our work, even when the end is not quickly in sight.

We live in a culture which expects immediate results, immediate gratification. However, like a well-chiseled piece of marble, there is something to be learned from the process, not just in the result.

May the Holy One of Blessing grant us the ability to see how we progress even when it might seem that we are standing still, and may we be given the endurance to see our projects to a successful end. May this be God's will.—AMEN.

Dear Mr. Wilson: Parties interested in the content of SB 877 have expressed differing interpretation of the bill on the issue of pricing of deposition transcripts. It is my intent that SB 877 have no impact on pricing decisions; thus there is no mention of price in SB 877.

This statement of the legislative intent is based in no small part on an exchange of correspondence between the National Court Reporters Association (NCRA) and the Antitrust Division of the U.S. Department of Justice (Justice).

NCRA requested a "business review letter" of Justice regarding a proposed Contracting Policy based upon NCRA's Code of Professional Ethics that would relate to contracts between court reporters and parties to a litigation. The request contained the following language:

"It should be noted that NCRA was careful to draft its proposed Contracting Policy in a way that would not infringe upon the pricing decision of its members. The proposed Contracting Policy is intended merely to prevent court reporters from discriminating between parties to the same action in terms of the types of services offered."

The response of Justice contained the following:

"Professional Codes of Ethics serve many salutary purposes. If, however, ethical codes have the purpose or effect of restraining price or quality competition, limiting output, or discouraging innovation, the promulgation and enforcement of such codes can raise significant antitrust risks. To avoid raising antitrust concerns, amendments to NCRA's Code of Ethics should observe the following guidelines:

1. They should not have the purpose or the effect of discouraging court reporters from entering into long term contacts, contracts with volume discounts or other fee discount provisions, or contracts with any other innovative terms, or otherwise discouraging competition among court reporters.
2. Any change to NCRA's Code of ethics should be accompanied by an affirmative statement to NCRA's membership that the changes are not intended, and NCRA does not intend generally, to prohibit or discharge long term contracts, volume discounts, fee discounts or other innovative contract terms, or otherwise discourage competition among court reporters. Each court reporter should determine independently what services it will offer and what prices it will charge."

Given the reality of the position of the Department of Justice, SB 877 does not seek to regulate price or discourage competition among reporters.
